4 **RESOLUTION 2026-250**

5 A RESOLUTION CONFIRMING THE COUNCIL PRESIDENT'S  
6 APPOINTMENT OF BRIAN SMALL, A DUVAL COUNTY  
7 RESIDENT, AS A LAY MEMBER OF THE MOBILITY SYSTEM  
8 WORKING GROUP, PURSUANT TO SECTION 655.509  
9 (MOBILITY SYSTEM WORKING GROUP), PART 5  
10 (MOBILITY SYSTEM), CHAPTER 655 (CONCURRENCY AND  
11 MOBILITY MANAGEMENT SYSTEM), *ORDINANCE CODE*, TO  
12 SERVE FOR A TERM ENDING WHEN THE CITY COUNCIL  
13 TAKES FINAL ACTION ON THE RECOMMENDATIONS OF THE  
14 MOBILITY SYSTEM WORKING GROUP; PROVIDING AN  
15 EFFECTIVE DATE.

17 **WHEREAS**, Section 655.509, *Ordinance Code*, requires the Planning  
18 Department to evaluate the Mobility System and Chapter 655  
19 (Concurrency and Mobility Management System) of the *Ordinance Code*  
20 with respect to the Mobility System, within two years following the  
21 adoption of the North Florida Transportation Planning Organization's  
22 Long Range Transportation Plan ("LRTP"), but at least once every ten  
23 years regardless of receipt of the LRTP, and shall update the Mobility  
24 System as provided in Section 655.504, *Ordinance Code*; and

25 **WHEREAS**, the Planning Department shall conduct an analysis and  
26 present recommendations of appropriate amendments to the Mobility  
27 System and Chapter 655 to the Mobility System Working Group, which  
28 shall be convened for the purpose of reviewing and approving such  
29 recommendations; and

30 **WHEREAS**, the Mobility System Working Group shall be comprised  
31 of seven members, with one City Council member appointed by the City

1 Council President, two lay citizens appointed by the City Council  
2 President, three lay members appointed by the Mayor, and one lay  
3 member appointed jointly by the Mayor and the City Council President;  
4 and

5 **WHEREAS**, the Planning Department shall provide the Mayor and the  
6 Council with recommendations approved by the Mobility System Working  
7 Group (the "Recommendations") for action by the legislative and  
8 executive branches of government within 90 days after the approval;  
9 and

10 **WHEREAS**, all members of the Mobility System Working Group shall  
11 serve until the City Council takes final action on the  
12 Recommendations; now therefore

13 **BE IT RESOLVED** by the Council of the City of Jacksonville:

14 **Section 1. Confirmation of Appointment.** The Council hereby  
15 confirms the Council President's appointment of Brian Small, a Duval  
16 County resident, as a lay member of the Mobility System Working Group,  
17 in accordance with Section 655.509, *Ordinance Code*, to serve for a  
18 term ending when the City Council takes final action on the  
19 Recommendations.

20 **Section 2. Effective Date.** This Resolution shall become  
21 effective upon signature by the Mayor or upon becoming effective  
22 without the Mayor's signature.
