6 AN ORDINANCE APPROPRIATING \$10,000 FROM THE
7 SPECIAL COUNCIL CONTINGENCY ACCOUNT TO THE ESP
8 - PRETEEN AND TEEN PROGRAMMING - SUBSIDIES AND
9 CONTRIBUTIONS TO PRIVATE ORG ACCOUNT WITHIN THE
10 KIDS HOPE ALLIANCE ("KHA") FUND TO PROVIDE
11 FUNDING TO GIRL SCOUTS OF GATEWAY COUNCIL, INC.
12 ("GIRL SCOUTS") FOR THE COMMUNITY DEVELOPMENT
13 TROOPS PROGRAM (THE "PROGRAM") AS DESCRIBED
14 HEREIN; PROVIDING FOR CARRYOVER TO FISCAL YEAR
15 2025-2026; AMENDING THE SIXTH REVISED SCHEDULE
16 M TO ORDINANCE 2024-511-E; WAIVING CERTAIN
17 REQUIREMENTS OF SECTION 77.111 (CONTRACTS;
18 CONTRACT ADMINISTRATION; CARRYOVER), CHAPTER 77
19 (KIDS HOPE ALLIANCE), *ORDINANCE CODE*, TO EXEMPT
20 THE SERVICES TO BE PROVIDED BY GIRL SCOUTS FROM
21 COMPETITIVE PROCUREMENT; APPROVING, AND
22 AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE
23 CORPORATION SECRETARY, AND/OR THE CHIEF
24 EXECUTIVE OFFICER OF KHA TO EXECUTE AND DELIVER
25 AN AMENDMENT TO THE AGREEMENT BETWEEN THE CITY
26 OF JACKSONVILLE OR KHA AND GIRL SCOUTS OF
27 GATEWAY COUNCIL, INC. FOR THE PROGRAM; PROVIDING
28 FOR OVERSIGHT BY KHA; PROVIDING AN EFFECTIVE
29 DATE.

31 **BE IT ORDAINED** by the Council of the City of Jacksonville:

1 Scouts staff. Girls participating in the Program receive free
2 membership, uniforms, Program supplies, and transportation assistance
3 when needed to ensure cost is never a deterrent to participation.
4 The City funds will be used to offset costs associated with staffing
5 the Program with four troop leaders.

6 **Section 3. Carryover.** The funds appropriated herein shall
7 not lapse but shall carryover to fiscal year 2025-2026.

8 **Section 4. Amending the Sixth Revised Schedule M to**
9 **Ordinance 2024-511-E.** The Kids Hope Alliance fiscal year 2024-2025
10 budget approved by Ordinance 2024-511-E is hereby amended by
11 substituting in place of the Sixth Revised Schedule M, the Seventh
12 Revised Schedule M, attached hereto as **Exhibit 3** and incorporated
13 herein by this reference, to reflect the funds appropriated herein.

14 **Section 5. Waiving Certain Requirements of Section 77.111,**
15 **Ordinance Code.** The City hereby waives certain requirements of
16 Section 77.111 (Contracts; contract administration; carryover),
17 Chapter 77 (Kids Hope Alliance), *Ordinance Code*, with respect to the
18 contract with Girl Scouts approved and authorized by this Ordinance.
19 Specifically, subsection 77.111(a) requires Provider Contracts for
20 children's services provided by third parties to be competitively
21 procured by KHA via an evaluated bid process. This waiver is needed
22 in order to allow KHA to directly contract with Girl Scouts of Gateway
23 Council, Inc. for the Community Development Troops Program described
24 in **Exhibit 2**.

25 **Section 6. Approval and Authorization to Execute Amendment**
26 **to Agreement.** There is hereby approved, and the Mayor, or her
27 designee, and the Corporation Secretary, and/or the Chief Executive
28 Officer of KHA, are hereby authorized to execute and deliver on behalf
29 of the City or KHA, an amendment to the agreement with Girl Scouts
30 of Gateway Council, Inc., to increase the maximum indebtedness by an
31 amount not-to-exceed \$10,000. The agreement shall continue to be

1 subject to and administered in accordance with Chapter 77, *Ordinance*
2 *Code*, and is subject to the terms, scope and budget more particularly
3 described in **Exhibit 2**, for a term commencing on July 1, 2025 through
4 June 30, 2026, and all other contracts and documents, including
5 extensions, renewals and amendments to the agreement, and to otherwise
6 take all action necessary to effectuate the intent of this Ordinance,
7 subject to appropriate legal review and approval by the General
8 Counsel, or his designee, and the City's Risk Management Division for
9 appropriate insurance and indemnification requirements in accordance
10 with Section 128.601, *Ordinance Code*.

11 **Section 7. Oversight Department.** The Kids Hope Alliance
12 shall oversee the project described herein.

13 **Section 8. Effective Date.** This Ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
