The purpose of the public hearing is to receive comments and hear discussion concerning the issuance by the Authority of its Multifamily Housing Rev-enue Bonds (Lofts at San Marco East), Series 2022, in an aggregate face amount of not to exceed \$23,800,000 (the "Bonds"). The proceeds of the Bonds will be oaned to, Lolls at San Marco East, Ltd., or its permitted suc-cessors and assigns (the "Company"), and used for the purpose of financing all or a portion of the costs related to the acquisition, construction and equipping of a multifamily residential housing facility for persons or families of low, middle or moderate income located at 3036 and 3114 Phil-ips Highway, Jacksonville, Daval County, Florida, 32207, consisting of approximately 172 units to be commonly known as Lofts at San Marco East, Ifk/a Tori Meadows (the "Project"). Lofts at San Marco East, Ltd., or its affiliate is expected to be the owner and operator of the Project.

All interested persons are invit-

ed to attend said hearing and, either personally or through their representatives, present oral or written comments and discussion concerning the proposed issu-ance of the Bonds for the purposes described in the preceding paragraph and the nature and location of the Project. Should any person decide to appeal any decision made by the Authority at this hearing, or by the Council of the City of Jacksonville (the "City") with respect to the approval of the issuance of the Bonds for the purposes described in the preceding paragraph, he or she will need a record of the pro-ceedings, and he or she may need to insure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
