7 DONATION TO FIRST COAST CRIME STOPPERS TO
8 ADMINISTER THE SHERIFF'S GUN BOUNTY PROGRAM, A
9 PROGRAM THAT SUPPORTS DRUG TREATMENT, DRUG
10 ABUSE EDUCATION, DRUG PREVENTION, CRIME
11 PREVENTION, SAFE NEIGHBORHOODS, AND SCHOOL
12 RESOURCE OFFICER PROGRAMS, AS INITIATED BY
13 B.T. 20-091; APPROVING AND AUTHORIZING THE
14 MAYOR, OR HIS DESIGNEE, AND THE CORPORATION
15 SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF
16 THE CITY THE MISCELLANEOUS APPROPRIATIONS
17 AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND
18 FIRST COAST CRIME STOPPERS, INCORPORATED;
19 PROVIDING AN EFFECTIVE DATE.

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
23 within the City's budget, there are hereby appropriated the
24 indicated sum(s) from the account(s) listed in subsection (a) to
25 the account(s) listed in subsection (b):

1 (c) Explanation of Appropriation

2 The funding above is an appropriation from the Special
3 Law Enforcement Trust Fund (the "Fund") for a donation to
4 First Coast Crime Stoppers to administer the Sheriff's
5 Gun Bounty Program. The existing revenue balance within
6 the Fund will be used to increase Budgeted Revenues by
7 \$150,000.00 and will increase the appropriation in
8 expenditure by \$150,000.00.

9 **Section 2. Purpose.** The purpose of the appropriation in
10 Section 1 is to provide a donation to First Coast Crime Stoppers to
11 administer the Sheriff's Gun Bounty Program. This allocation
12 supports drug treatment, drug abuse education, drug prevention,
13 crime prevention, safe neighborhoods, and school resource officer
14 programs. A Certification that the request from the Special Law
15 Enforcement Trust Fund complies with §932.7055, Florida Statutes,
16 is attached hereto as **Exhibit 2** and incorporated herein by this
17 reference.

18 **Section 3. Approval and authorization.** There is hereby
19 approved, and the Mayor, or his designee, and the Corporation
20 Secretary are hereby authorized to execute and deliver on behalf of
21 the City the Miscellaneous Appropriations Agreement between the
22 City of Jacksonville and First Coast Crime Stoppers, Incorporated,
23 in substantially the same form placed **ON FILE** with the Office of
24 Legislative Services.

25 **Section 4. Effective Date.** This ordinance shall become
26 effective upon signature by the Mayor or upon becoming effective
27 without the Mayor's signature.
