6 AN ORDINANCE APPROPRIATING \$60,000, INCLUDING  
7 \$10,000 TO SIGMA BETA CLUB OF JACKSONVILLE INC.,  
8 \$10,000 TO DELTA SIGMA THETA SORORITY, INC.,  
9 JACKSONVILLE ALUMNAE CHAPTER, \$10,000 TO KAPPA  
10 ALPHA PSI JACKSONVILLE FOUNDATION,  
11 INCORPORATED, \$10,000 TO BETA ALPHA ZETA CHAPTER  
12 OF ZETA PHI BETA SORORITY, INC., \$10,000 TO  
13 OMEGAS 4 CHANGE, INC. (AFFILIATE OF OMEGA PSI  
14 PHI THETA PHI CHAPTER, INC.), AND \$10,000 TO  
15 ALPHA-JAX FOUNDATION, INC. (GAMMA RHO OMEGA  
16 CHAPTER, INC. OF ALPHA KAPPA ALPHA SORORITY),  
17 FROM DESIGNATED CONTINGENCY ACCOUNTS WITHIN THE  
18 GENERAL FUND TO THE SUBSIDIES AND CONTRIBUTIONS  
19 TO PRIVATE ORGANIZATIONS ACCOUNT WITHIN THE KIDS  
20 HOPE ALLIANCE ("KHA") FUND TO PROVIDE FUNDING  
21 FOR VARIOUS YOUTH PROGRAMS AND SERVICES (THE  
22 "PROGRAMS") AS DESCRIBED HEREIN; AMENDING THE  
23 FOURTH REVISED SCHEDULE M TO ORDINANCE  
24 2023-511-E; INVOKING THE EXEMPTION IN SECTION  
25 126.107(G) (EXEMPTIONS), PART 1 (GENERAL  
26 REGULATIONS), CHAPTER 126 (PROCUREMENT CODE),  
27 *ORDINANCE CODE*, TO ALLOW FOR DIRECT CONTRACTS  
28 WITH SIGMA BETA CLUB OF JACKSONVILLE INC., DELTA  
29 SIGMA THETA SORORITY, INC., JACKSONVILLE ALUMNAE  
30 CHAPTER, KAPPA ALPHA PSI JACKSONVILLE

1 CHAPTER OF ZETA PHI BETA SORORITY, INC., OMEGAS  
2 4 CHANGE, INC. (AFFILIATE OF OMEGA PSI PHI THETA  
3 PHI CHAPTER, INC.), AND ALPHA-JAX FOUNDATION,  
4 INC. (GAMMA RHO OMEGA CHAPTER, INC. OF ALPHA  
5 KAPPA ALPHA SORORITY) FOR THE PROGRAMS; WAIVING  
6 THE REQUIREMENTS OF SECTION 77.111(A) (PROVIDER  
7 CONTRACTS), CHAPTER 77 (KIDS HOPE ALLIANCE),  
8 *ORDINANCE CODE*, TO EXEMPT THE SERVICES TO BE  
9 PROVIDED BY THE AFOREMENTIONED ORGANIZATIONS  
10 FROM COMPETITIVE PROCUREMENT; APPROVING, AND  
11 AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND  
12 CORPORATION SECRETARY, AND/OR THE CHIEF  
13 EXECUTIVE OFFICER OF KHA TO EXECUTE AND DELIVER,  
14 AN AGREEMENT BETWEEN THE CITY AND SIGMA BETA  
15 CLUB OF JACKSONVILLE INC., DELTA SIGMA THETA  
16 SORORITY, INC., JACKSONVILLE ALUMNAE CHAPTER,  
17 KAPPA ALPHA PSI JACKSONVILLE FOUNDATION,  
18 INCORPORATED, BETA ALPHA ZETA CHAPTER OF ZETA  
19 PHI BETA SORORITY, INC., OMEGAS 4 CHANGE, INC.  
20 (AFFILIATE OF OMEGA PSI PHI THETA PHI CHAPTER,  
21 INC.), AND ALPHA-JAX FOUNDATION, INC. (GAMMA RHO  
22 OMEGA CHAPTER, INC. OF ALPHA KAPPA ALPHA  
23 SORORITY) FOR THE PROGRAMS; PROVIDING FOR  
24 OVERSIGHT BY KHA; PROVIDING AN EFFECTIVE DATE.

26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
28 within the City's budget, there is hereby appropriated the indicated  
29 sum(s) from the account(s) listed in subsection (a) to the account(s)  
30 listed in subsection (b):

6 (c) Explanation of Appropriation:

7 The funding above is an appropriation of \$60,000 from  
8 Designated Contingency accounts within the General Fund to  
9 the Subsidies and Contributions to Private Organizations  
10 account within the Kids Hope Alliance ("KHA") Fund to  
11 provide funding for various youth programs and services as  
12 described herein, to include \$10,000 to Sigma Beta Club of  
13 Jacksonville Inc., \$10,000 to Delta Sigma Theta Sorority,  
14 Inc., Jacksonville Alumnae Chapter, \$10,000 to Kappa Alpha  
15 Psi Jacksonville Foundation, Incorporated, \$10,000 to Beta  
16 Alpha Zeta Chapter of Zeta Phi Beta Sorority, Inc., \$10,000  
17 to Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta  
18 Phi Chapter, Inc.), and \$10,000 to Alpha-Jax Foundation,  
19 Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha  
20 Sorority).

21 **Section 2. Purpose.** The purpose of the appropriation in  
22 Section 1 is to provide funding from the City of Jacksonville to  
23 Sigma Beta Club of Jacksonville Inc., Delta Sigma Theta Sorority,  
24 Inc., Jacksonville Alumnae Chapter, Kappa Alpha Psi Jacksonville  
25 Foundation, Incorporated, Beta Alpha Zeta Chapter of Zeta Phi Beta  
26 Sorority, Inc., Omegas 4 Change, Inc. (affiliate of Omega Psi Phi  
27 Theta Phi Chapter, Inc.), and Alpha-Jax Foundation, Inc. (Gamma Rho  
28 Omega Chapter, Inc. of Alpha Kappa Alpha Sorority), for the provision  
29 of youth programs and services in Duval County as more particularly  
30 described in the Term Sheets attached hereto as **Exhibit 2** and  
31 incorporated herein by this reference (the "Programs"). The Programs

1 are designed to encourage youth participants to engage in leadership  
2 opportunities and to pursue higher education. Several of the Programs  
3 will use the City funding to provide expanded scholarship  
4 opportunities to eligible students who pursue higher education. In  
5 addition, several of the Programs will use the City funding to cover  
6 the costs for students and youth who desire to attend education and  
7 leadership conferences and/or trips to visit colleges and  
8 universities that are sponsored by the recipient organizations.

9 **Section 3. Amending Fourth Revised Schedule M to Ordinance**  
10 **2023-511-E.** The Kids Hope Alliance fiscal year 2023-2024 budget  
11 approved by Ordinance 2023-511-E is hereby amended by substituting  
12 in the place of the Fourth Revised Schedule M, the Fifth Revised  
13 Schedule M, attached hereto as **Exhibit 3** and incorporated herein by  
14 this reference. The Fifth Revised Schedule M reflects the funds  
15 appropriated herein.

16 **Section 4. Invoking the Exemption in Section 126.107(g),**  
17 **Ordinance Code.** The City is hereby authorized to directly procure  
18 the professional services of Sigma Beta Club of Jacksonville Inc.,  
19 Delta Sigma Theta Sorority, Inc., Jacksonville Alumnae Chapter, Kappa  
20 Alpha Psi Jacksonville Foundation, Incorporated, Beta Alpha Zeta  
21 Chapter of Zeta Phi Beta Sorority, Inc., Omegas 4 Change, Inc.  
22 (affiliate of Omega Psi Phi Theta Phi Chapter, Inc.), and Alpha-Jax  
23 Foundation, Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha  
24 Sorority), for the provision of youth programs and services. Pursuant  
25 to Section 126.107(g) (Exemptions), Part 1 (General Regulations),  
26 Chapter 126 (Procurement Code), *Ordinance Code*, such procurement is  
27 exempted from competitive solicitation because the supplies or  
28 services are to be provided by those specifically prescribed within  
29 authorizing legislation that appropriates the same. With the  
30 exception of the foregoing, all other provisions of Chapter 126,  
31 *Ordinance Code*, shall remain in full force and effect.

1           **Section 5.           Waiving the Requirements of Section 77.111(a),**  
2 **Ordinance Code.** The City hereby waives the requirements of Section  
3 77.111(a) (Provider Contracts), Chapter 77 (Kids Hope Alliance),  
4 *Ordinance Code*, with respect to the contracts with Sigma Beta Club  
5 of Jacksonville Inc., Delta Sigma Theta Sorority, Inc., Jacksonville  
6 Alumnae Chapter, Kappa Alpha Psi Jacksonville Foundation,  
7 Incorporated, Beta Alpha Zeta Chapter of Zeta Phi Beta Sorority,  
8 Inc., Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta Phi  
9 Chapter, Inc.), and Alpha-Jax Foundation, Inc. (Gamma Rho Omega  
10 Chapter, Inc. of Alpha Kappa Alpha Sorority), approved and authorized  
11 by this Ordinance. Section 77.111(a) requires contracts for  
12 children's services provided by third parties to be competitively  
13 procured by KHA via an evaluated bid process. This waiver is needed  
14 in order to allow KHA to directly contract with Sigma Beta Club of  
15 Jacksonville Inc., Delta Sigma Theta Sorority, Inc., Jacksonville  
16 Alumnae Chapter, Kappa Alpha Psi Jacksonville Foundation,  
17 Incorporated, Beta Alpha Zeta Chapter of Zeta Phi Beta Sorority,  
18 Inc., Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta Phi  
19 Chapter, Inc.), and Alpha-Jax Foundation, Inc. (Gamma Rho Omega  
20 Chapter, Inc. of Alpha Kappa Alpha Sorority), to provide the youth  
21 programs and services described in **Exhibit 2.**

22           **Section 6.           Approval and Authorization to Execute**  
23 **Agreements.** There is hereby approved, and the Mayor, or her designee,  
24 and the Corporation Secretary, and/or the Chief Executive Officer of  
25 KHA, are hereby authorized to execute and deliver on behalf of the  
26 City, agreements with the following entities for the specified  
27 not-to-exceed amounts: Sigma Beta Club of Jacksonville Inc.  
28 (\$10,000), Delta Sigma Theta Sorority, Inc., Jacksonville Alumnae  
29 Chapter (\$10,000), Kappa Alpha Psi Jacksonville Foundation,  
30 Incorporated (\$10,000), Beta Alpha Zeta Chapter of Zeta Phi Beta  
31 Sorority, Inc. (\$10,000), Omegas 4 Change, Inc. (affiliate of Omega

1 Psi Phi Theta Phi Chapter, Inc.) (\$10,000), and Alpha-Jax Foundation,  
2 Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha Sorority)  
3 (\$10,000), subject to the Term Sheet for each organization attached  
4 hereto as **Exhibit 2**, for a term commencing on October 1, 2023 through  
5 September 30, 2024, and all other contracts and documents, including  
6 extensions, renewals and amendments to the agreements, and to  
7 otherwise take all action necessary to effectuate the intent of this  
8 Ordinance, subject to appropriate legal review and approval by the  
9 Office of General Counsel and the City's Risk Management Division for  
10 appropriate insurance and indemnification requirements in accordance  
11 with Section 128.601, *Ordinance Code*.

12 **Section 7. Oversight Department.** The Kids Hope  
13 Alliance shall oversee the programs described herein.

14 **Section 8. Effective Date.** This Ordinance shall become  
15 effective upon signature by the Mayor or upon becoming effective  
16 without the Mayor's signature.
