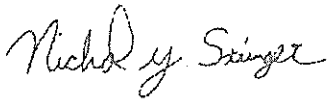

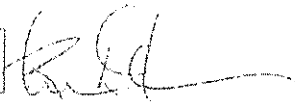
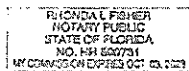

**NOTICE OF
PUBLIC HEARING**
NOTICE IS HEREBY GIVEN, pursuant to Section 117.1 of the Internal Revenue Code of 1986, as amended, of a public hearing by the Jacksonville Housing Finance Authority (the "Authority") to be held on February 10, 2025 at 10:00 a.m. or as soon thereafter as possible. The public hearing will be held via the following toll-free telephonic conference line in lieu of physical presence at the public hearing:

The purpose of the public hearing is to receive comments and hear discussion concerning the issuance by the Authority of its Multifamily Housing Revenue Bonds (Sulzbacher Enterprise Village) is one of more series, in an aggregate face amount of not to exceed \$47,000,000 (the "Bonds"). The proceeds of the Bonds will be loaned to Sulzbacher Enterprise Housing, Ltd. or its permitted successors, and assigns (the "Company"), and used for the purpose of financing all or a portion of the costs related to the acquisition and construction of a multifamily residential housing facility for low, middle or moderate income persons to be located at Wadgreen Road, approximately 2,150 feet north of the intersection of Wadgreen Road and Gollair Boulevard, Jacksonville, Duval County, Florida, consisting of approximately 100 units to be more commonly known as Sulzbacher Enterprise Village (the "Project"). Sulzbacher Enterprise Housing, Ltd. or its affiliate is expected to be the owner and operator of the Project.

All interested persons are invited to attend said hearing and, either personally or through their representatives, present oral or written comment and discussion concerning the proposed issuance of the Bonds for the purposes described in the preceding paragraph and the nature and location of the Project. Written comments may be submitted to the Jacksonville Housing Finance Authority, 211 N. Hogan Street, 7th Floor, Jacksonville, Florida 32202. Should any person decide to appeal any decision made by the Authority at this hearing, or by the Council of the City of Jacksonville (the "City"), with respect to the approval of the issuance of the Bonds for the purposes described in the preceding paragraph, he or she will need a record of the proceedings, and he or she may need to invoke that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. Comments made at the hearing are for the consideration of the Authority, the City and will not bind the Authority or the City to any action it may take.

All interested persons are invited to attend and be heard and present their comments.
