5 AN ORDINANCE APPROPRIATING \$77,440.00 IN GRANT
6 FUNDING FROM THE FLORIDA FISH AND WILDLIFE
7 CONSERVATION COMMISSION (THE "FWC") FOR
8 REIMBURSEMENT OF THE CITY OF JACKSONVILLE'S
9 COSTS TO REMOVE AND DISPOSE OF FOUR DERELICT
10 VESSELS LOCATED IN PUBLIC WATERWAYS ALL WITHIN
11 DUVAL COUNTY, AS INITIATED BY B.T. 26-054;
12 PROVIDING FOR OVERSIGHT BY THE OFFICE OF
13 ADMINISTRATIVE SERVICES, ENVIRONMENTAL QUALITY
14 DIVISION; PROVIDING AN EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2025-2026 fiscal year,
18 within the City's budget, there are hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

27 (c) Explanation of Appropriation:

28 The funding above represents an appropriation of \$77,440.00
29 in grant funding from the Florida Fish and Wildlife
30 Conservation Commission (the "FWC") for reimbursement to
31 the City of the costs to remove and dispose of four derelict

1 vessels located in public waterways within Duval County.

2 No local match is required.

3 **Section 2. Purpose.** The purpose of the appropriation in
4 Section 1 is to appropriate grant funding from the FWC to offset the
5 City's costs for removal and disposal of four derelict vessels located
6 in public waterways within Duval County. Pursuant to that certain
7 State of Florida Fish and Wildlife Conservation Commission Agreement
8 No. 25220 (the "Agreement"), a copy of which has been placed **On File**
9 with the Legislative Services Division, the FWC will reimburse the
10 City up to \$77,440.00 for removal of a white 21' Chapparral Open Motor
11 Boat, a white 32' Carver Cabin Motorboat, a white 30' Cal Sailboat,
12 and a white 34' Lindsey Sailboat, located in Ribault River, Trout
13 River, Clapboard Creek, and the St. Johns River at Kurzius Beach.
14 Removal of these vessels must occur prior to the expiration of the
15 Agreement on August 6, 2026. Upon removal, the vessels will be taken
16 to an authorized landfill facility for disposal.

17 **Section 3. Oversight.** The Office of Administrative
18 Services, Environmental Quality Division shall have oversight of the
19 project as described herein.

20 **Section 4. Effective Date.** This Ordinance shall become
21 effective upon signature by the Mayor or upon becoming effective
22 without the Mayor's signature.
