AN ORDINANCE RESCHEDULING THE LAND USE AND ZONING COMMITTEE MEETING OF TUESDAY, MAY 16, 2023, TO WEDNESDAY, MAY 17, 2023; DIRECTING APPROPRIATE NOTIFICATION BY THE CHIEF OF THE LEGISLATIVE SERVICES DIVISION; WAIVING COUNCIL RULE 2.201 (MEETINGS) TO AUTHORIZE THE RESCHEDULING; REQUESTING EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Council Rule 2.201 (Meetings) provides for Standing Committee meetings to be held during the first and third weeks of every month (except for the first week in July and the third week in December); and

WHEREAS, pursuant to Council Rule 2.201 (Meetings), the Council President has set the regular meeting of the Land Use and Zoning Committee for the first and third Tuesdays of each month (except for the first week in July and the third week in December); and

WHEREAS, the Land Use and Zoning Committee is scheduled to meet on Tuesday, May 16, 2023, which is the date of the 2023 Unitary General Election; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Land Use and Zoning Committee Meeting on Tuesday, May 16, 2023 Rescheduled. The Land Use and Zoning Committee meeting scheduled for Tuesday, May 16, 2023 in the Council Chambers is hereby rescheduled to Wednesday, May 17, 2023 at 5:00 p.m. in the Council Chambers. The Land Use and Zoning Committee agenda meeting is also hereby rescheduled to Wednesday, May 17, 2023 at 4:30 p.m.

in Council Chambers.

Section 2. Notification. The Chief of Legislative Services is hereby directed to ensure that all public hearings are advertised and scheduled for Wednesday, May 17, 2023, and to ensure that any other notifications necessary to conduct the Land Use and Zoning Committee meeting and agenda meeting on Wednesday, May 17, 2023, are made.

Section 3. Council Rule 2.201 (Meetings) Waived. Pursuant to Council Rule 2.201 (Meetings), the Council President has set the regular meetings of the Land Use and Zoning Committee for the first and third Tuesdays of each month (except for the first week in July and the third week in December). Council Rule 2.201 (Meetings) is hereby waived to authorize the rescheduling of the Land Use and Zoning Committee meeting as stated herein.

Pursuant to Council Rule 4.901. Emergency passage of this legislation upon introduction is requested. The nature of the emergency is that bills filed on April 5, 2023, and introduced at the City Council meeting on April 11, 2023, will be scheduled for public hearings before the Land Use and Zoning Committee during the third week of May. Emergency passage of this legislation upon introduction ensures City staff has time to prepare and issue revised notices and advertisements for these hearings to provide as much advance notice as possible of the rescheduled Land Use and Zoning Committee meeting to May 17, 2023.

Section 5. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
