4 **RESOLUTION 2021-161**

5 A RESOLUTION CONFIRMING THE REAPPOINTMENT OF
6 GERALDINE (LOCKETT) JACKSON AS A JEA
7 REPRESENTATIVE TO THE CIVIL SERVICE BOARD OF THE
8 CITY OF JACKSONVILLE, PURSUANT TO SECTION 17.02
9 OF THE CHARTER OF JACKSONVILLE, FOR A FIRST FULL
10 TERM TO EXPIRE JUNE 30, 2023; PROVIDING AN
11 EFFECTIVE DATE.

13 **WHEREAS**, the Legislature of the State of Florida has enacted
14 chapter 2004-437, Laws of Florida, pursuant to which Sections 17.02,
15 17.10, and 17.12 of the Charter of the City of Jacksonville, as
16 created by chapter 92-341, Laws of Florida, as amended, were amended
17 to revise the membership of the Civil Service Board of the City of
18 Jacksonville; and

19 **WHEREAS**, Section 17.02(b), as amended, of the Charter of the City
20 of Jacksonville, Laws of Florida, requires JEA to appoint two members
21 to the Civil Service Board; and

22 **WHEREAS**, Resolution 2019-58-A confirmed the appointment of
23 Geraldine (Lockett) Jackson as a JEA representative for a partial
24 term to expire June 30, 2020; and

25 **WHEREAS**, the JEA Board approved the reappointment of Geraldine
26 Lockett to the Civil Service Board by resolution on January 28, 2021,
27 a copy of the JEA resolution is attached hereto as **Exhibit 1**; and

28 **WHEREAS**, pursuant to Section 17.02(b), as amended, of the Charter
29 of the City of Jacksonville, Laws of Florida, appointments to the
30 Civil Service Board are required to be approved by the City Council;
31 now therefore

1 **BE IT RESOLVED** by the Council of the City of Jacksonville:

2 **Section 1. Confirmation of Reappointment.** The Council does
3 hereby confirm and approve the reappointment of Geraldine Lockett, a
4 Duval County resident, as a JEA representative to the Civil Service
5 Board of the City of Jacksonville, pursuant to Section 17.02 of the
6 Charter of the City of Jacksonville, for a first full term to expire
7 June 30, 2023. Attached hereto as **Exhibit 2** is the *curriculum vitae*
8 of Geraldine (Lockett) Jackson.

9 **Section 2. Effective Date.** This resolution shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
