26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Amending Section 53.102 (Membership;**
28 **appointment and removal; terms of office), Part 1 (Renew Arlington**
29 **Community Redevelopment Agency Advisory Board) Chapter 53 (Community**
30 **Redevelopment Agency Advisory Boards), *Ordinance Code*. Section**
31 **53.102 (Membership; appointment and removal; terms of office), Part**

1 (Renew Arlington Community Redevelopment Agency Advisory Board),
2 Chapter 53 (Community Redevelopment Agency Advisory Boards),
3 *Ordinance Code*, is hereby amended to read as follows:

4 **CHAPTER 53 - COMMUNITY REDEVELOPMENT AGENCY ADVISORY BOARDS**

5 **PART 1. - RENEW ARLINGTON COMMUNITY REDEVELOPMENT AGENCY ADVISORY**

8 **Sec. 53.102. - Membership; appointment and removal; terms of office.**

9 (a) The Advisory Board shall consist of nine members to be
10 appointed within the following categories with preference
11 given to persons that reside or work within the Renew
12 Arlington Community Redevelopment Area:

13 (1) Category 1: One member shall be a representative of
14 the planning, landscape architecture or architecture
15 fields.

16 (2) Category 2: One member shall be a business owner that
17 owns at least one business located within one mile of
18 the CRA boundary.

19 (3) Category 3: One member shall be in the banking,
20 insurance, or finance profession.

21 (4) Category 4: One member shall be from the marketing,
22 public relations, or advertising profession.

23 (5) Category 5: Two members shall be citizens representing
24 the general public that live within a three-mile~~one-~~
25 ~~mile~~ radius of the CRA boundary, and east and south of
26 the river.

27 (6) Category 6: One member shall be in the public
28 policy/economic development profession, but shall not
29 be a registered lobbyist with the City of
30 Jacksonville.

31 (7) Category 7: Two members shall own at least one

1 commercial parcel within the CRA boundary.

7 53.202 (Membership; appointment and removal; terms of office), Part
8 2 (KingSoutel Crossing Community Redevelopment Agency Advisory
9 Board), Chapter 53 (Community Redevelopment Agency Advisory Boards),
10 *Ordinance Code*, is hereby amended to read as follows:

16 (a) The Advisory Board shall consist of seven members to be
17 appointed within the following categories with preference
18 given to persons that reside or work within the KingSoutel
19 Crossing Community Redevelopment Area:

20 (1) *Category 1:* One member shall be a representative of
21 the planning, landscape architecture or architecture
22 fields.

23 (2) *Category 2:* One member shall be in the banking,
24 insurance, or finance profession.

25 (3) *Category 3:* One member shall be from the engineering
26 or construction management profession.

27 (4) *Category 4:* Four members shall be citizens
28 representing the general public that live, work or own
29 a business within three miles~~one mile~~ of the CRA
30 boundary.

1 **Section 3. Codification Instructions.** The Codifier and the
2 Office of General Counsel are authorized to make all chapter and
3 division "table of contents" consistent with the changes set forth
4 herein. Such editorial changes and any other changes necessary to
5 make the *Ordinance Code* consistent with the intent of this legislation
6 are approved and directed herein, and the changes to the *Ordinance*
7 *Code* shall be made forthwith and when inconsistencies are discovered.

8 **Section 4. Effective Date.** This Ordinance shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
