5 AN ORDINANCE APPROPRIATING GRANT FUNDS IN THE
6 AMOUNT OF \$105,000.00 FROM THE COMMUNITY
7 FOUNDATION OF NORTHEAST FLORIDA TO PROVIDE
8 MENTAL HEALTH, LIFE SKILLS COACHING, AND DRUG
9 TREATMENT AND SERVICES FOR TEEN COURT PROGRAM
10 PARTICIPANTS, AS INITIATED BY B.T. 22-047;
11 PURPOSE OF APPROPRIATION; PROVIDING FOR
12 CARRYOVER OF FUNDS TO FISCAL YEAR 2024-2025;
13 PROVIDING FOR OVERSIGHT AND REPORTING BY THE
14 COURT ADMINISTRATION, DIRECTOR OF TEEN COURTS;
15 PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
19 within the City’s budget, there is hereby appropriated the indicated
20 sum(s) from the account(s) listed in subsection (a) to the account(s)
21 listed in subsection (b):

28 (c) Explanation of Appropriation
29 The funding above is an appropriation of grant funds from
30 the Community Foundation of Northeast Florida to provide
31 certain services to Teen Court program participants as

1 outlined herein (the "Grant"). The Grant period commenced
2 on February 1, 2022 and continues through February 28,
3 2025. No local match is required.

4 **Section 2. Purpose.** The purpose of the appropriation in
5 Section 1 is to provide funding for mental health, life skills
6 coaching, and drug treatment and services for Teen Court program
7 participants. The Grant helps to cover the gap in funding for these
8 critical services. This is a three-year grant at \$35,000.00 per year
9 for a total grant amount of \$105,000.00. A copy of the Grant Contract
10 and Grant award letter is attached hereto as **Exhibit 2.**

11 **Section 3. Carryover.** The funds appropriated in this
12 Ordinance shall not lapse but shall carryover to fiscal year 2024-
13 2025.

14 **Section 4. Oversight and Reporting.** The Court
15 Administration, Director of Teen Courts, shall provide oversight of
16 the grant described herein. The Director of Teen Courts shall also
17 be responsible to provide grant activity reports to the Community
18 Foundation of Northeast Florida in accordance with the terms of the
19 grant.

20 **Section 5. Effective Date.** This Ordinance shall become
21 effective upon signature by the Mayor or upon becoming effective
22 without the Mayor's signature.
