7 GENERAL FUND OPERATING LAPSE CONTINGENCY ACCOUNT
8 TO THE IGOD INSPECTOR GENERAL - FINANCIAL AND
9 ADMINISTRATION - EXPENDITURE CREDIT-CONTINGENT
10 LAPSE ACCOUNT, TO RESTORE FUNDING TO THE OFFICE
11 OF INSPECTOR GENERAL THAT WAS PLACED IN A LAPSE
12 CONTINGENCY ACCOUNT IN THE CITY'S FISCAL YEAR
13 2025-2026 BUDGET PURSUANT TO ORDINANCE 2025-504-
14 E; PROVIDING AN EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2025-2026 fiscal year,
18 within the City's budget, there is hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

27 (c) Explanation of Appropriation:

28 The funding above is an appropriation of \$27,780 from the
29 General Fund Operating Lapse Contingency account to the
30 IGOD Inspector General - Financial and Administration -
31 Expenditure Credit-Contingent Lapse account, to restore

1 funding to the Office of Inspector General that was placed
2 in a lapse contingency account in the City's Fiscal Year
3 2025-2026 budget pursuant to Ordinance 2025-504-E.

4 **Section 2. Purpose.** The purpose of the appropriation in
5 Section 1 is to restore the 2% operating lapse to the Office of
6 Inspector General which had been placed in a lapse contingency account
7 during the Fiscal Year 2025-2026 budget process. The Special
8 Committee on Duval DOGE has reviewed the Office of Inspector General's
9 request for reinstatement of said funds and determined that sufficient
10 justification exists to recommend the City Council's approval of the
11 request.

12 **Section 3. Effective Date.** This Ordinance shall become
13 effective upon signature by the Mayor or upon becoming effective
14 without the Mayor's signature.
