5 AN ORDINANCE APPROPRIATING \$560,168.08 IN  
6 UNAPPROPRIATED INVESTMENT POOL EARNINGS WITHIN  
7 THE SOUTHSIDE COMMUNITY REDEVELOPMENT AGENCY  
8 ("CRA") TRUST FUND OF WHICH \$110,432.03 WILL TO  
9 BE ALLOCATED TO THE RIVERPLACE BOULEVARD CRA  
10 PROJECT AND \$449,736.05 TO FUTURE YEAR DEBT  
11 REDUCTION, AS INITIATED BY B.T. 21-058; PURPOSE  
12 OF APPROPRIATION; PROVIDING AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Appropriation.** For the 2020-2021 fiscal year,  
16 within the City's budget, there is hereby appropriated the indicated  
17 sum(s) from the account(s) listed in subsection (a) to the account(s)  
18 listed in subsection (b):

26 The funding above comprises an appropriation of \$560,168.08  
27 in Southside CRA Trust Fund Investment Pool Earnings to be  
28 allocated to the Riverside Boulevard CRA project  
29 (\$110,432.03) and future year debt reduction(\$449,736.05).

30 **Section 2. Purpose.** The purpose of the appropriation in  
31 Section 1 is to allocate \$110,432.03 in unappropriated Southside CRA

1 Trust Fund Investment Pool Earnings ("CRA Funds") for payment of  
2 existing change orders to close out the completed Riverside Boulevard  
3 CRA project, and \$449,736.05 in CRA Funds to future year debt  
4 reduction. This appropriation was approved by the Downtown Investment  
5 Authority Board on September 16, 2020 pursuant to Resolution 2020-  
6 02-08, a copy of which is attached hereto as **Exhibit 2** and  
7 incorporated herein by this reference.

8 **Section 3. Effective Date.** This Ordinance shall become  
9 effective upon signature by the Mayor or upon becoming effective  
10 without the Mayor's signature.
