Special Council Reserve - Police and Fire Contingency account to set the funds aside for public safety uses should the need arise during Fiscal Year 2025-2026.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to set aside funds in Fiscal Year 2025-2026 so they will be available for the City's public safety providers should the need arise to support their services and/or operations.
