4 **ORDINANCE 2024-462-E**

5 AN ORDINANCE APPROPRIATING \$5,000 FROM A
6 DESIGNATED CONTINGENCY ACCOUNT TO THE SUBSIDIES
7 AND CONTRIBUTIONS TO PRIVATE ORG ACCOUNT TO
8 PROVIDE FUNDING TO IMPERFECT PEOPLE CENTER,
9 INC., FOR HEALTH AND AWARENESS WORKSHOPS THAT
10 ADDRESS CRITICAL HEALTH ISSUES IN DUVAL COUNTY,
11 FLORIDA AS DESCRIBED HEREIN; INVOKING THE
12 EXEMPTION IN SECTION 126.107(G) (EXEMPTIONS),
13 PART 1 (GENERAL REGULATIONS), CHAPTER 126
14 (PROCUREMENT CODE), *ORDINANCE CODE*, TO ALLOW FOR
15 A DIRECT CONTRACT WITH IMPERFECT PEOPLE CENTER,
16 INC.; WAIVING SECTION 118.107 (NONPROFITS TO
17 RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED
18 AWARD PROCESS), PART 1 (GENERAL PROVISIONS),
19 CHAPTER 118 (CITY GRANTS), *ORDINANCE CODE*, TO
20 ALLOW FOR A DIRECT CONTRACT WITH IMPERFECT
21 PEOPLE CENTER, INC.; APPROVING, AND AUTHORIZING
22 THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION
23 SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF
24 THE CITY AN AGREEMENT BETWEEN THE CITY OF
25 JACKSONVILLE AND IMPERFECT PEOPLE CENTER, INC.
26 FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY THE
27 GRANTS AND CONTRACTS COMPLIANCE DIVISION OF THE
28 FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

30 **BE IT ORDAINED** by the Council of the City of Jacksonville:

31 **Section 1. Appropriation.** For the 2023-2024 fiscal year,

1 within the City's budget, there is hereby appropriated the indicated
2 sum(s) from the account(s) listed in subsection (a) to the account(s)
3 listed in subsection (b):

10 (c) Explanation of Appropriation:

11 The funding above is an appropriation of \$5,000 from a
12 Designated Contingency account to the Subsidies and
13 Contributions to Private Org account to provide funding to
14 Imperfect People Center, Inc. ("IPC") for health and
15 awareness workshops aimed at addressing critical health
16 issues prevalent in Duval County, Florida (the "Program").

17 **Section 2. Purpose.** The purpose of the appropriation in
18 Section 1 is to provide funding from the City of Jacksonville to IPC
19 for the Program as described in **Exhibit 2**, attached hereto and
20 incorporated herein by this reference. The Program is designed to
21 provide education and awareness focused primarily on HIV and sexually
22 transmitted infections as well as mental health awareness. The City
23 funds appropriated herein will allow IPC to provide the Program and
24 related services to a minimum of 50 residents within Duval County.

25 **Section 3. Invoking the Exemption in Section 126.107(g),**
26 **Ordinance Code.** The City is hereby authorized to directly procure
27 the professional services of Imperfect People Center, Inc. to
28 administer the Program described herein. Pursuant to Section
29 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126
30 (Procurement Code), *Ordinance Code*, such procurement is exempted from
31 competitive solicitation because the supplies or services are to be

1 provided by those specifically prescribed within authorizing
2 legislation that appropriates the same. With the exception of the
3 foregoing, all other provisions of Chapter 126, *Ordinance Code*, shall
4 remain in full force and effect.

5 **Section 4. Waiver of Section 118.107, *Ordinance Code*.** The
6 provisions of Section 118.107 (Nonprofits to receive funding through
7 a competitive evaluated award process), Part 1 (General Provisions),
8 Chapter 118 (City Grants), *Ordinance Code*, are hereby waived to allow
9 for a direct contract with Imperfect People Center, Inc. This waiver
10 is justified because IPC has been hosting health awareness workshops
11 within the community for over a decade and is well versed in the
12 needs of the target audience. The overall mission of IPC encompasses
13 a comprehensive approach to education, prevention, and support
14 services to empower residents with the knowledge and resources to
15 make informed decisions about their health and wellbeing. The City
16 funds appropriated herein will allow IPC to provide health and
17 awareness workshops to reach additional residents in Duval County.

18 **Section 5. Approval and Authorization to Execute.** There is
19 hereby approved, and the Mayor, or her designee, and the Corporation
20 Secretary are hereby authorized to execute and deliver on behalf of
21 the City an agreement with Imperfect People Center, Inc. in an amount
22 not-to-exceed \$5,000, subject to the Scope of Services and Budget
23 more particularly described in **Exhibit 2**, for a term commencing on
24 October 1, 2023 through September 30, 2024, and all other contracts
25 and documents, including extensions, renewals and amendments to the
26 agreement, and to otherwise take all action necessary to effectuate
27 the intent of this Ordinance, subject to appropriate legal review and
28 approval by the General Counsel, or his or her designee, and the
29 City's Risk Management Division for appropriate insurance and
30 indemnification requirements in accordance with Section 128.601,
31 *Ordinance Code*.

1 **Section 6. Oversight Department.** The Grants and
2 Contract Compliance Division of the Finance Department shall oversee
3 the project described herein.

4 **Section 7. Effective Date.** This Ordinance shall become
5 effective upon signature by the Mayor or upon becoming effective
6 without the Mayor's signature.
