

## PELUSO FLOOR AMENDMENT

Council Member Peluso offers the following Floor Amendment to File No. 2025-275:

- (1) On **page 1, line 18**, after "FMPA;" insert "WAIVING SECTION 118.201(F)(7) (RELEASE OF APPROPRIATIONS), PART 2 (DISBURSEMENT OF CITY GRANTS), CHAPTER 118 (CITY GRANTS), *ORDINANCE CODE*, TO ALLOW FOR AN ADVANCE PAYMENT OF \$25,000 TO FPMA AND TO AUTHORIZE TWO EQUAL INSTALLMENTS OF \$12,500 THEREAFTER AS DESCRIBED HEREIN;"
- (2) On **page 2, line 17**, strike "Exhibit 2" and insert "Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev Term Sheet & Budget, June 10, 2025 - Floor""
- (3) On **page 3, line 1**, after "costs." insert "The City funds will be paid in three installments of which the initial payment of \$25,000 will be an advance payment as authorized herein, the remaining funds will be paid in two equal installments of \$12,500 subject to the City's receipt of supporting documentation for qualified expense of the previous disbursement as more particularly described in Revised Exhibit 2.";
- (4) On **page 3, line 11½**, insert a new Section 5 to read as follows:

"Section 5.      **Waiver of Section 118.201(f)(7), Ordinance Code.** The provisions of Section 118.201(f)(7) (Release of Appropriations), Part 2 (Disbursement of City Grants), Chapter 118 (City Grants), *Ordinance Code*, are

hereby waived to allow for an advance payment of the City funds in the amount of \$25,000 and to authorize two equal disbursements of \$12,500 thereafter as more particularly described herein. This waiver is justified because it will allow for additional funds to be available to initiate the Program, recognizing a number of the costs to establish the Program will be incurred immediately.”;

- (5) Renumber the remaining Sections accordingly;
- (6) On **page 3, line 17, strike “Exhibit 2” and insert “Revised Exhibit 2”**;
- (7) Remove **Exhibit 2** and replace with **Revised Exhibit 2**, attached hereto, which attaches the revised Term Sheet and Budget for the Program to reflect payments being made in installments;
- (8) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
