AN ORDINANCE APPROPRIATING \$5,000,000.00 FROM HUD CDBG-DR IRMA THE FUNDING THROUGH THE FLORIDA DEPARTMENT OF ECONOMIC OPPORTUNITY TO THE CITY OF JACKSONVILLE CDBG-DR HURRICANE IRMA VOLUNTARY HOME BUYOUT PROGRAM TO ALLOW THE CITY TO ADDRESS DIRECTLY THE DAMAGE FROM HURRICANE IRMA BY REMOVING STRUCTURES WERE IMPACTED BY STORM SURGE AND RIVERINE FLOODING, AS INITIATED BY REVISED B.T. 20-100; APPROVING AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY EXECUTE AND DELIVER ON BEHALF OF THE CITY THE FEDERALLY-FUNDED COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY (CDBG-DR) VOLUNTARY HOME BUYOUT PROGRAM SUBRECIPIENT AGREEMENT; PROVIDING FOR OVERSIGHT BY THE HOUSING AND COMMUNITY DEVELOPMENT DIVISION OF THE NEIGHBORHOODS DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

(C) Explanation of Appropriation

> The funding above is an appropriation from the HUD CDBG-DR Irma Funding through the Florida Department of Economic Opportunity to the City of Jacksonville CDBG-DR Hurricane Irma Voluntary Home Buyout Program (the "Program") to allow the City to address directly the damage from Hurricane Irma by removing structures that were impacted by storm surge and riverine flooding.

One of the communities hardest Section 2. Background. hit by Hurricane Irma was the Ken Knight Drive Neighborhood in Washington Heights. This community has a very high concentration of individuals and families living at or below the poverty level. The homes in the community were built in the 1960s or earlier and are well below the base flood elevation. Very few, if any, of the properties were covered by flood insurnce and nearly all of the properties were severely damaged by the flooding event. Given the condition of a majority of these structures, repairing the homes is not a feasible option.

Section 3. Purpose. The purpose of the appropriation in Section 1 is to allow the City to address directly the damage from Hurricane Irma by removing structures that were impacted by storm surge and riverine flooding through the Program. The Program will reduce future public costs associated with evacuation and rescue,

emergency shelter, temporary housing, home repairs, financial assistance, and debris removal services following tropical cyclone and flooding events. In addition, the Program will reduce the financial burden on taxpayers caused by having to fund repeatedly subsidized repairs of these properties that were built within the The Program will also remove current 100-year floodplain. residents from immediate dangers as well as from the emotional and financial toll associated with future flooding events. Finally, the Program will provide the residents of the neighborhood the opportunity to obtain alternative, affordable housing outside of the floodplain. The properties acquired through the Program will be returned to green space, which will also improve local flood storage and conveyance, and will be deed-restricted so as to prohibit the building of new structures that inevitably would be damaged by future flooding.

Section 4. Approval and authorization. There is hereby approved, and the Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City the Federally-Funded Community Development Block Grant Disaster Recovery (CDBG-DR) Voluntary Home Buyout Program Subrecipient Agreement, in substantially the same form placed On File with the Office of Legislative Services.

Section 5. Oversight. The Housing and Community Development Division of the Neighborhoods Department shall oversee the Program.

Section 6. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
