The Agreement will allow the City to exchange its approximately 2.3 acre portion of Goodby's Creek Preserve (RE# 148713-0100) for privately owned property of approximately 52 acres (RE#149242-0000 at 33.04 acres and RE# 149239-0000 at 18.75 acres). See maps attached. The City's property contains a conservation easement and is valued by the property appraiser at \$470.00. The private property has a combined value of \$15,483 by the property appraiser. No money will be exchanged for the land swap.

As a result of the exchange, the City will expand its park area/ Goodby's Creek Preserve as well as add property around the existing boat ramp.


