The ordinance involves a street re-naming of a portion of Church Street to Ray Charles Place. The purpose of the street re-naming is to honor the late and well known musician, Ray Charles, because he lived in Jacksonville on the designated portion of Church Street for a period of time. His contribution to the music industry in Jacksonville continues to have a positive impact on the arts and culture in Florida and world-wide.
