10 SECTION 11.104, *ORDINANCE CODE*; REQUESTING ONE  
11 CYCLE EMERGENCY PASSAGE; PROVIDING FOR A  
12 PROSPECTIVE APPOINTMENT EFFECTIVE DATE;

15 **WHEREAS,** the Personnel Committee of the City Council convened  
16 on April 15, 2025, for the purpose of selecting the Chief of the City  
17 Council Legislative Services Division, as described in Section  
18 11.104, *Ordinance Code*; and

19 **WHEREAS,** the Personnel Committee has nominated Bernadette D.  
20 Smith for appointment as Chief of the Legislative Services Division  
21 and forwards this recommendation to the City Council for consideration  
22 and confirmation; now therefore

23 **BE IT RESOLVED** by the Council of the City of Jacksonville:

24 **Section 1. Confirmation of Appointment.** The City Council  
25 hereby confirms the appointment of Bernadette D. Smith as Chief of  
26 the City Council Legislative Services Division, pursuant to Section  
27 11.104, *Ordinance Code*, to perform the duties and responsibilities,  
28 and to serve under the terms, all as set forth in Chapter 11, *Ordinance*  
29 *Code*.

30 **Section 2. Requesting One Cycle Emergency Passage Pursuant**  
31 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this

1 legislation is requested. The nature of the emergency is that the  
2 Chief of Legislative Services position has been vacant for several  
3 weeks and the Council would like to fill the vacancy as soon as  
4 possible.

5       **Section 3.       Prospective Appointment Effective Date.** The  
6 appointment made herein shall become effective on May 17, 2025.

7       **Section 4.       Effective Date.** This Resolution shall become  
8 effective upon enactment by the City Council.
