4 **ORDINANCE 2026-173-E**

5 AN ORDINANCE APPROVING APPLICATION FOR ZONING  
6 EXCEPTION E-26-12 FOR PROPERTY LOCATED IN  
7 COUNCIL DISTRICT 2 AT 2467 FAYE ROAD, AT THE  
8 CORNER OF FAYE ROAD AND ALTA DRIVE (R.E. NO(S).  
9 108655-0000), AS DESCRIBED HEREIN, OWNED BY 2467  
10 FAYE RD., LLC, REQUESTING AN ESTABLISHMENT OR  
11 FACILITY WHICH INCLUDES THE RETAIL SALE OF BEER  
12 OR WINE FOR ON-PREMISES CONSUMPTION, FOR THAI  
13 NINE, LLC, D/B/A THAI NINE, IN THE COMMERCIAL  
14 NEIGHBORHOOD (CN) DISTRICT, AS DEFINED AND  
15 CLASSIFIED UNDER THE ZONING CODE; ADOPTING  
16 RECOMMENDED FINDINGS AND CONCLUSIONS OF THE LAND  
17 USE AND ZONING COMMITTEE; PROVIDING FOR  
18 DISTRIBUTION; PROVIDING AN EFFECTIVE DATE.

20 **WHEREAS**, an application for a zoning exception, **On File** with  
21 the City Council Legislative Services Division, was filed by Lawrence  
22 Yancy, on behalf of the owner of property located in Council District  
23 2 at 2467 Faye Road, at the corner of Faye Road and Alta Drive (R.E.  
24 No(s). 108655-0000) (the "Subject Property"), requesting an  
25 establishment or facility which includes the retail sale of beer or  
26 wine for on-premises consumption, for Thai Nine, LLC, D/B/A Thai  
27 Nine, in the Commercial Neighborhood (CN) District; and

28 **WHEREAS**, the Planning and Development Department has  
29 considered the application and all attachments thereto and has  
30 rendered an advisory recommendation; and

31 **WHEREAS**, the Land Use and Zoning Committee, after due notice,

1 held a public hearing and having duly considered both the testimonial  
2 and documentary evidence presented at the public hearing, has made  
3 its recommendation to the Council; now therefore

4 **BE IT ORDAINED** by the Council of the City of Jacksonville:

5 **Section 1. Adoption of Findings and Conclusions.** The  
6 Council has considered the recommendation of the Land Use and Zoning  
7 Committee and reviewed the Staff Report of the Planning and  
8 Development Department concerning application for zoning exception  
9 E-26-12. Based upon the competent, substantial evidence contained in  
10 the record, the Council hereby determines that the requested zoning  
11 exception meets each of the following criteria required to grant the  
12 request pursuant to Section 656.131(c), *Ordinance Code*, as  
13 specifically identified in the Staff Report of the Planning and  
14 Development Department:

15 (1) Will be consistent with the Comprehensive Plan, including  
16 any subsequent plan adopted by the Council pursuant thereto;

17 (2) Will be compatible with the existing contiguous uses or  
18 zoning and compatible with the general character of the area,  
19 considering population density, design, scale and orientation of  
20 structures to the area, property values, and existing similar uses  
21 or zoning;

22 (3) Will not have an environmental impact inconsistent with the  
23 health, safety and welfare of the community;

24 (4) Will not have a detrimental effect on vehicular or pedestrian  
25 traffic, or parking conditions, and will not result in the generation  
26 or creation of traffic inconsistent with the health, safety and  
27 welfare of the community;

28 (5) Will not have a detrimental effect on the future development  
29 of contiguous properties or the general area, according to the  
30 Comprehensive Plan, including any subsequent amendment to the plan  
31 adopted by the Council;

1 (6) Will not result in the creation of objectionable or  
2 excessive noise, lights, vibrations, fumes, odors, dust or physical  
3 activities, taking into account existing uses or zoning in the  
4 vicinity;

5 (7) Will not overburden existing public services and facilities;

6 (8) Will be sufficiently accessible to permit entry onto the  
7 property by fire, police, rescue and other services; and

8 (9) Will be consistent with the definition of a zoning  
9 exception, and will meet the standards and criteria of the zoning  
10 classification in which such use is proposed to be located, and all  
11 other requirements for such particular use set forth elsewhere in the  
12 Zoning Code, or otherwise adopted by the Planning Commission or  
13 Council.

14 Therefore, zoning exception application E-26-12 is hereby  
15 approved.

16 **Section 2. Owner and Description.** The Subject Property is  
17 owned by 2467 Faye Rd., LLC, and is described in **Exhibit 1**, dated  
18 December 31, 2025, and graphically depicted in **Exhibit 2**, both  
19 attached hereto. The applicant is Lawrence Yancy, 1309 Saint Johns  
20 Bluff Road North, Building A, Suite 2, Jacksonville, Florida, 32225;  
21 (904) 568-4317.

22 **Section 3. Distribution by Legislative Services.**  
23 Legislative Services is hereby directed to mail a copy of this  
24 legislation, as enacted, to the applicant and any other parties to  
25 this matter who testified before the Land Use and Zoning Committee  
26 or otherwise filed a qualifying written statement as defined in  
27 Section 656.140(c), *Ordinance Code*.

28 **Section 4. Effective Date.** The enactment of this Ordinance  
29 shall be deemed to constitute a quasi-judicial action of the City  
30 Council and shall become effective upon signature by the Council  
31 President and Council Secretary. Failure to exercise the zoning

1 exception, if herein granted, by the commencement of the use or action  
2 herein approved within one (1) year of the effective date of this  
3 legislation shall render this zoning exception invalid and all rights  
4 arising therefrom shall terminate.
