> The funding above is an appropriation of \$32,311.41 from the Permanent and Probationary Salaries account and various benefits accounts within the Insured Programs Fund (56301) to fund salary and benefits within the Self Insurance Fund for one full-time position and to fund salary increases for two current employees.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to fund a Risk Operations Manager position to support the business needs of the Finance Department, including high level financial support, claims analytics and actuarial analysis, and systems and compliance support. Additionally, this position will enable necessary backup and succession planning. This appropriation will also fund salary increases for two current employees within the Self Insurance Fund.

Section 3. Authorization of One Full-Time Position and the Deletion of One Full-Time Position. There is hereby approved the addition of one full-time Risk Operations Manager position within the Self Insurance Fund and the deletion of one full-time Workers' Compensation Claims Manager position within the Self Insurance Fund within the Finance Department as more fully described in R.C. 25-007, attached hereto as **Exhibit 2** and incorporated herein by this reference.
