- (1) On page 1, line 17, after "CONTRACTS" <u>insert</u> "WITH THE EXCEPTION THAT SUCH PROHIBITION SHALL NOT APPLY TO AGREEMENTS FOR MEDICAL SERVICES PROVIDED BY SHANDS JACKSONVILLE MEDICAL CENTER, INC. ("SHANDS") OR TO PROGRAMS OR SERVICES FOR VICTIMS OF LABOR AND/OR SEX TRAFFICKING";
- (2) On page 1, line 25 and page 2, line 1, after "ALIENS" <u>insert</u> "WITH THE EXCEPTION THAT SUCH PROHIBITION SHALL NOT APPLY TO AGREEMENTS FOR MEDICAL SERVICES PROVIDED BY SHANDS OR TO PROGRAMS OR SERVICES FOR VICTIMS OF LABOR AND/OR SEX TRAFFICKING";
- (3) On page 2, line 2, after "INSTRUCTIONS;" <u>insert</u> "ESTABLISHING A PROSPECTIVE EFFECTIVE DATE OF JULY 1, 2026, FOR THE AMENDMENTS TO SECTION 77.111, ORDINANCE CODE, CONTAINED IN THIS ORDINANCE TO BECOME EFFECTIVE;";
- (4) On page 4, line 17, after "<u>Statutes</u>" insert ", with the exception that such prohibition shall not apply to Provider <u>Contracts for medical services provided by Shands Jacksonville</u> <u>Medical Center, Inc. or to Provider Contracts for programs or</u> services for victims of labor and/or sex trafficking";
- (5) On page 4, line 30, after "<u>Statutes</u>" <u>insert</u> ", with the exception that such prohibition shall not apply to Small <u>Provider Contracts for medical services provided by Shands</u> <u>Jacksonville Medical Center</u>, Inc. or to Small Provider

Contracts for programs or services for victims of labor and/or sex trafficking";

- (6) On page 5, line 15, after "<u>Statutes</u>" insert ", with the exception that such prohibition shall not apply to Intra-Agency or other agreements for medical services provided by Shands Jacksonville Medical Center, Inc. or to Intra-Agency or other agreements for programs or services for victims of labor and/or sex trafficking";
- (7) On page 6, line 4 and page 7, line 9, after "<u>Statutes</u>" insert ", with the exception that such prohibition shall not apply to agreements for medical services provided by Shands Jacksonville <u>Medical Center, Inc. or to agreements for programs or services</u> for victims of labor and/or sex trafficking";
- (8) On page 7, line 16¹/₂, <u>insert</u> a new Section 6 to read as follows: "Section 6. Establishing a Prospective Effective Date of July 1, 2026, for the Amendments to Section 77.111, Ordinance Code, Contained in this Ordinance to Become Effective. The Code amendments to Section 77.111, Ordinance Code, contained in this Ordinance shall not become effective until July 1, 2026.";
- (9) Renumber the remaining Section accordingly;
- (10) On page 1, line 1, amend the introductory sentence to add that the bill was amended as reflected herein.
