4 **ORDINANCE 2025-185**

5 AN ORDINANCE APPROVING, AND AUTHORIZING THE
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION
7 SECRETARY TO EXECUTE AND DELIVER AN AMENDMENT TO
8 THE AMENDED AND RESTATED AGREEMENT BETWEEN THE
9 CITY OF JACKSONVILLE AND SHANDS JACKSONVILLE
10 MEDICAL CENTER, INC. (THE "AMENDMENT"), TO
11 ADJUST THE ELIGIBILITY FOR COVERAGE PROCESS,
12 HAVE FINANCIAL EVALUATIONS CONDUCTED ON AN
13 ANNUAL BASIS AND TO REVISE THE SCHEDULE D TO THE
14 AGREEMENT; PROVIDING FOR CONTINUED OVERSIGHT BY
15 THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE
16 DATE.

18 **WHEREAS**, Resolution 2005-393, approved the Amended and
19 Restated Agreement Between the City of Jacksonville and Shands
20 Jacksonville Medical Center, Inc., dated June 2, 2005 (the
21 "Agreement"); and

22 **WHEREAS**, the Council Auditor's Office conducted an audit of
23 the Agreement and reported its findings to the City Council in Report
24 #881, dated August 18, 2024; and

25 **WHEREAS**, the parties desire to amend the Agreement based upon
26 the findings in Report #881 and to address other changes requested
27 by the City; now therefore

28 **BE IT ORDAINED** by the Council of the City of Jacksonville:

29 **Section 1. Approval and Authorization to Execute Amendment**
30 **to Amended and Restated Agreement.** There is hereby approved, and the
31 Mayor, or her designee, and the Corporation Secretary are hereby

1 authorized to execute and deliver, that certain Amendment to Amended
2 and Restated Agreement Between the City of Jacksonville and Shands
3 Jacksonville Medical Center, Inc., in substantially the same form
4 attached hereto as **Exhibit 1** and incorporated herein by this
5 reference, to adjust the eligibility for coverage process, have
6 financial evaluations conducted on an annual basis and to revise the
7 Schedule D to the Agreement, with all other terms and conditions of
8 the Agreement remaining unchanged.

9 **Section 2. Oversight.** The Finance Department shall have
10 oversight of the Amendment described herein.

11 **Section 3. Effective Date.** This Ordinance shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
