

RULES AMENDMENT

The Rules Committee offers the following amendment to File No. 2024-76:

- (1) On **page 1, line 6**, after "J. SAHBUDAK," **insert** "A CLAY COUNTY RESIDENT";
- (2) On **page 1, line 8 and page 2, line 4**, **strike** "Sherry Jackson" and **insert** "Ryan Ertel";
- (3) On **page 1, lines 12-14**, **strike** "PARTIAL TERM TO EXPIRE ON DECEMBER 31, 2024, FOLLOWED BY A FIRST FULL TERM TO EXPIRE ON DECEMBER 31, 2027" and **insert** "FIRST FULL TERM TO EXPIRE ON DECEMBER 31, 2026";
- (4) On **page 1, line 14**, after "2027;" **insert** "ESTABLISHING SUBSTANTIAL ECONOMIC BUSINESS INTEREST IN DUVAL COUNTY, PURSUANT TO SECTION 50.102(B) (MEMBERS OF BOARDS AND COMMISSIONS), PART 1 (ORGANIZATION), CHAPTER 50 (ORGANIZATION OF BOARDS AND COMMISSIONS), *ORDINANCE CODE*";";
- (5) On **page 1, lines 15-21**, **strike** "EMERGENCY PASSAGE UPON INTRODUCTION; WAIVING COUNCIL RULE 4.1101 (APPEARANCE BEFORE COMMITTEE), *COUNCIL RULES*, AS TO THE REQUIREMENT THAT THE APPOINTEE, PRIOR TO CONFIRMATION, SHALL APPEAR BEFORE THE COMMITTEE TO WHICH CONSIDERATION OF THE APPOINTMENT HAS BEEN REFERRED" and **insert** "ONE CYCLE EMERGENCY PASSAGE; WAIVING SECTION 50.102(C) (MEMBERS OF BOARDS AND COMMISSIONS), PART 1 (ORGANIZATION), CHAPTER 50 (ORGANIZATION OF BOARDS AND COMMISSIONS), *ORDINANCE CODE*, AS TO THE REQUIREMENT THAT THE BILL SPONSOR APPEAR BEFORE THE RULES COMMITTEE PRIOR TO THE APPEARANCE OF THE APPOINTEE";

- (6) On **page 2, line 2, strike** "Duval" and **insert** "Clay";
- (7) On **page 2, lines 7-8, strike** "partial term to expire on December 31, 2024, followed by a first full term to expire on December 31, 2027" and **insert** "first full term to expire on December 31, 2026";
- (8) On **page 2, line 8½, insert** a new Section 2 to read as follows:
"Section 2. Establishing Substantial Economic Business Interest in Duval County. Section 50.102(b) (Members of boards and commissions), Part 1 (Organization), Chapter 50 (Organization of Boards and Commissions), *Ordinance Code*, requires Board and Commission members be either permanent residents of Duval County or to maintain substantial economic business or philanthropic interest as determined by the City Council within Duval County. In this instance, although the appointee does not reside within Duval County, Ms. Sahbudak has substantial economic business interests in Duval County, serving as the President and Owner of Ocean Movers Inc., located at 8601 Youngerman Court, Unit 4 in Jacksonville and as the current General Manager of Jacksonville Quartz and Stone LLC, located at 8570 Philips Highway, Unit 109 in Jacksonville.";
- (9) On **page 2, line 9, strike** "2" and **insert** "3";
- (10) Renumber the remaining Sections accordingly;
- (11) On **page 2, line 9, strike** "Emergency Passage Upon Introduction" and **insert** "One Cycle Emergency Passage";
- (12) On **page 2, line 11, strike** "Emergency passage upon introduction" and **insert** "One cycle emergency passage";
- (13) On **page 2, lines 15-22, strike** all lines in their entirety and

insert a new Section to read as follows:

"Section 4. Waiver of Section 50.102(c), Ordinance Code. Section 50.102(c) (Members of boards and commissions), Part 1 (Organization), Chapter 50 (Organization of Boards and Commissions), *Ordinance Code*, is hereby waived as to the requirement that the bill sponsor appear before the Rules Committee prior to the appearance of the appointee. Because this legislation was filed requesting emergency passage by the Council, there was not sufficient time during the legislative process for the bill sponsor to appear prior to the appointee.";

- (14) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
