6 **RESOLUTION 2025-352-A**

7 A RESOLUTION CONFIRMING THE APPOINTMENT OF
8 SUZANNE PICKETT, A DUVAL COUNTY RESIDENT, AS A
9 MEMBER OF THE CULTURAL SERVICE GRANT PROGRAM
10 COMMITTEE, AS ONE OF THE THREE BOARD MEMBERS,
11 REPLACING TIM SNYDER, PURSUANT TO SECTION
12 118.605, *ORDINANCE CODE*, FOR A FIRST FULL TERM
13 EXPIRING DECEMBER 31, 2027; REQUESTING ONE CYCLE
14 EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, pursuant to Section 118.605(a), *Ordinance Code*, the
17 membership of the Cultural Service Grant Program (CSGP) Committee
18 shall include one non-voting and ten voting members: a CSGP Committee
19 chairperson (non-voting), appointed by the President of the Cultural
20 Council Board of Directors; three other Cultural Council Board members
21 selected by the Board President and Committee Chairperson; and seven
22 individuals selected by the above group (Cultural Council Board
23 President, CSGP Committee chairperson, and three selected Cultural
24 Council Board members) from a pool of nominations established through
25 a community wide nomination process; and

26 **WHEREAS**, pursuant to Section 118.605(d), *Ordinance Code*, all
27 members of the Cultural Service Grant Program Committee shall be
28 confirmed by the City Council; now therefore

29 **BE IT RESOLVED** by the Council of the City of Jacksonville:

30 **Section 1. Confirmation of Appointment.** The Council hereby
31 confirms the appointment of Suzanne Pickett, a Duval County resident,

1 to the Cultural Service Grant Program Committee, replacing Tim Snyder,
2 as one of the three board members, for a first full term expiring
3 December 31, 2027.

4 **Section 2. Requesting One Cycle Emergency Passage Pursuant**
5 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
6 legislation is requested. The nature of the emergency is to ensure
7 that the appointee is confirmed in a timely manner in order to attend
8 the Cultural Service Grant Program Committee's orientation which is
9 currently scheduled for Wednesday, June 4, 2025.

10 **Section 3. Effective Date.** This Resolution shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
