4 **ORDINANCE 2019-884-E**

5 AN ORDINANCE APPROVING AND AUTHORIZING THE  
6 TRANSFER FROM SUNSHINE RECYCLING, INC. TO WCA OF  
7 FLORIDA, LLC OF ITS NON-RESIDENTIAL SOLID WASTE  
8 COLLECTION AND TRANSPORTATION FRANCHISE PURSUANT  
9 TO SECTION 380.609, *ORDINANCE CODE*; PROVIDING AN  
10 EFFECTIVE DATE.

12 **WHEREAS**, pursuant to Resolution 2004-663-A, Sunshine  
13 Recycling, Inc. was granted a non-residential solid waste  
14 collection and transportation franchise (the "Franchise"); and

15 **WHEREAS**, WCA of Florida, LLC ("WCA") has filed an application  
16 for the transfer of the Franchise from Sunshine Recycling, Inc. to  
17 WCA; and

18 **WHEREAS**, the transfer of the Franchise will allow the existing  
19 franchise operator continued growth through a new corporate entity  
20 that has the financial stability and access to greater levels of  
21 capital to sustain that growth; and

22 **WHEREAS**, WCA has certified that it is financially fit and has  
23 sufficient experience in the solid waste collection and  
24 transportation business to adequately perform all of Sunshine  
25 Recycling, Inc.'s liabilities, obligations, conditions, and  
26 standards under the Franchise; and

27 **WHEREAS**, WCA has certified that it has the means to provide  
28 sufficient equipment and facilities to adequately perform all of  
29 Sunshine Recycling, Inc.'s liabilities, obligations, conditions,  
30 and standards under the Franchise; and

31 **WHEREAS**, the Department of Public Works recommends that WCA's

1 application for the transfer of the Franchise from Sunshine  
2 Recycling, Inc. to WCA be granted; now therefore

3 **BE IT ORDAINED** by the Council of the City of Jacksonville:

4 **Section 1. Transfer of Franchise authorized.** In  
5 accordance with the provisions of Chapter 380 (Solid Waste  
6 Management), Part 6 (Nonresidential Solid Waste Collection and  
7 Transportation Franchises), *Ordinance Code*, the Director of the  
8 Department of Public Works is hereby authorized to transfer the  
9 Franchise from Sunshine Recycling, Inc. to WCA. WCA shall be bound  
10 by the information provided in the application for transfer, which  
11 information is **on file** with the Legislative Services Division and  
12 by this reference incorporated herein. A copy of the Non-  
13 Residential Solid Waste Collection and Transportation Franchise  
14 Agreement is attached hereto as **Exhibit 1**.

15 **Section 2. Effective Date.** This ordinance shall become  
16 effective upon signature by the Mayor or upon becoming effective  
17 without the Mayor's signature.
