6 **ORDINANCE 2020-249**

7 AN ORDINANCE APPROPRIATING \$75,000 FROM
8 AUTHORIZED CAPITAL PROJECTS/INVESTMENT POOL
9 EARNINGS TO PROVIDE FUNDING FOR THE CREATION
10 AND INSTALLATION OF A FALLEN FIREFIGHTER
11 MEMORIAL AT FIRE STATION ONE ("PROJECT");
12 PROVIDING A CARRYOVER OF FUNDS FROM YEAR TO
13 YEAR UNTIL SUCH FUNDS ARE EXPENDED OR LAPSE
14 ACCORDING TO THE AGREEMENT; APPROVING AND
15 AUTHORIZING THE MAYOR OR HIS DESIGNEE AND
16 CORPORATION SECRETARY TO EXECUTE AND DELIVER
17 AN AGREEMENT ("AGREEMENT") WITH BRODIN
18 STUDIOS, INC. TO CREATE AND INSTALL THE
19 MEMORIAL IN ACCORDANCE WITH THE AGREEMENT;
20 REQUESTING THAT THE DEPARTMENT OF PUBLIC WORKS
21 OVERSEE THE AGREEMENT AND PROJECT; REQUESTING
22 ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN
23 EFFECTIVE DATE.

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
27 within the City's budget, and subject to receipt by the City of the
28 payments required under the settlement agreement (see Section 4
29 below), there are hereby appropriated the indicated sum(s) from the
30 account(s) listed in subsection (a) to the account(s) listed in
31 subsection (b):

7 (c) Explanation of Appropriation

8 The appropriation transfers \$75,000 from Authorized
9 Capital Projects/Investment Pool Earnings for the
10 installation of a fallen firefighter memorial and Fire
11 Station 1.

12 **Section 2. Purpose.** The purpose of the appropriation in
13 Section 1 is to pay for the installation of a fallen firefighter
14 memorial at Fire Station 1.

15 **Section 3. Carryover.** The funds appropriated herein shall
16 not lapse but shall carryover as appropriated from year to year
17 until such funds are expended or lapse according to the terms of
18 the Agreement.

19 **Section 4. Approving and Authorizing an agreement with**
20 **Brodin Studios, Inc. for the installation of the Memorial.** There
21 is hereby approved, and the Mayor and Corporation Secretary are
22 authorized to enter into an agreement ("Agreement") between the
23 City and Brodin Studios, Inc. ("Company"). Pursuant to the
24 Agreement, the Company will create and install the Memorial at Fire
25 Station 1, as further detailed in the Agreement ("Project"). The
26 Jacksonville Fire and Rescue Department shall obtain an
27 administrative award for the City to enter into the Agreement
28 pursuant to Section 126.107(a), *Ordinance Code*.

29 **Section 5. Oversight Department.** The Jacksonville Fire
30 and Rescue Department shall provide oversight for the Agreement and
31 Project.

1 **Section 6. Requesting one cycle emergency passage**
2 **pursuant to Council Rule 4.901 Emergency.** One cycle emergency
3 passage of this legislation is requested. The nature of the
4 emergency is that October 4, 2020, is National Fallen Firefighters
5 Memorial Weekend and the Fallen Firefighters Memorial project needs
6 to be completed prior to that date.

7 **Section 7. Effective Date.** This Ordinance shall become
8 effective upon signature by the Mayor or upon becoming effective
9 without the Mayor's signature.
