8 AN ORDINANCE APPROPRIATING \$98,005.21 FROM  
9 AVAILABLE REVENUE BALANCE IN THE DOMESTIC  
10 BATTERY SURCHARGE TRUST FUND (THE "FUND") TO  
11 ESTABLISH THE FISCAL YEAR 2023-2024 OPERATING  
12 BUDGET FOR THE FUND AND TO PROVIDE ADDITIONAL  
13 TRAINING TO LAW ENFORCEMENT PERSONNEL IN  
14 COMBATING DOMESTIC VIOLENCE, AS INITIATED BY  
15 B.T. 24-035; PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
19 within the City's budget, there is hereby appropriated the indicated  
20 sum(s) from the account(s) listed in subsection (a) to the account(s)  
21 listed in subsection (b):

29 The funding above is an appropriation of available revenue  
30 from County Court fines and investment pool earnings in

1 establish the fiscal year 2023-2024 operating budget for  
2 the Fund.

3 **Section 2. Purpose.** The purpose of the appropriation in  
4 Section 1 is to establish the fiscal year 2023-2024 operating budget  
5 for the Domestic Battery Surcharge Trust Fund. The funds will be used  
6 to provide additional training to law enforcement personnel in  
7 combating domestic violence.

8 **Section 3. Effective Date.** This Ordinance shall become  
9 effective upon signature by the Mayor or upon becoming effective  
10 without the Mayor's signature.
