## CARLUCCI FLOOR AMENDMENT

- (2) On page 1, line 10, after "ALIENS" <u>insert</u> ", AND (4) ALL FISCAL YEAR 2024-2025 BUDGETED AND ACTUAL EXPENDITURES, IN WHATEVER FORM, ON OR TO NON-PROFIT ENTITIES";
- (3) On page 1, line 14, <u>strike</u> "THE USE OF" and <u>insert</u> "THE PROVIDER, SMALL PROVIDER, AGENCY, OR RECIPIENT, AS APPLICABLE, FROM KNOWINGLY USING";
- (4) On page 1, line 17, after "CONTRACTS" <u>insert</u> "WITH THE EXCEPTION THAT SUCH PROHIBITION SHALL NOT APPLY TO AGREEMENTS FOR MEDICAL SERVICES PROVIDED BY SHANDS JACKSONVILLE MEDICAL CENTER, INC. ("SHANDS") OR TO PROGRAMS OR SERVICES FOR VICTIMS OF DOMESTIC VIOLENCE, LABOR TRAFFICKING, AND/OR SEX TRAFFICKING";
- (5) On page 1, line 24, after "FROM" insert "KNOWINGLY";
- (6) On page 1, line 25 and page 2, line 1, after "ALIENS" <u>insert</u> "WITH THE EXCEPTION THAT SUCH PROHIBITION SHALL NOT APPLY TO AGREEMENTS FOR MEDICAL SERVICES PROVIDED BY SHANDS OR TO PROGRAMS OR SERVICES FOR VICTIMS OF DOMESTIC VIOLENCE, LABOR TRAFFICKING, AND/OR SEX TRAFFICKING";
- (7) On page 1, lines 30-31, strike "USE OF" and insert "THE RECIPIENT FROM KNOWINGLY USING";
- (8) On page 2, line 2, after "INSTRUCTIONS;" <u>insert</u> "ESTABLISHING
  A PROSPECTIVE EFFECTIVE DATE OF JULY 1, 2026, FOR THE

AMENDMENTS TO SECTION 77.111, ORDINANCE CODE, CONTAINED IN THIS ORDINANCE TO BECOME EFFECTIVE;";

- (9) On page 3, line 12<sup>1</sup>/<sub>2</sub>, <u>insert</u> new language to read as follows:
  "d) Expenditures on Non-Profits:
  - Information regarding any and all budgeted and actual expenditures, in whatever form, on or to non-profit entities in fiscal year 2024-2025.";
- (10) On page 4, line 14, strike "the use of" and insert "the Provider from knowingly using";
- (11) On page 4, line 17, after "<u>Statutes</u>" insert ", with the exception that such prohibition shall not apply to Provider Contracts for medical services provided by Shands Jacksonville Medical Center, Inc. or to Provider Contracts for programs or services for victims of domestic violence, labor trafficking, and/or sex trafficking";
- (12) On page 4, line 28, strike "the use of" and insert "the Small Provider from knowingly using";
- (13) On page 4, line 30, after "<u>Statutes</u>" <u>insert</u> ", with the exception that such prohibition shall not apply to Small Provider Contracts for medical services provided by Shands Jacksonville Medical Center, Inc. or to Small Provider Contracts for programs or services for victims of domestic violence, labor trafficking, and/or sex trafficking";
- (14) On page 5, line 13, <u>strike</u> "the use of" and <u>insert</u> "the Agency or recipient, as applicable, from knowingly using";
- (15) On page 5, line 15, after "<u>Statutes</u>" insert ", with the exception that such prohibition shall not apply to Intra-Agency or other agreements for medical services provided by Shands Jacksonville Medical Center, Inc. or to Intra-Agency or other

agreements for programs or services for victims of domestic violence, labor trafficking, and/or sex trafficking";

- (16) On page 6, line 1, <u>strike</u> "the use of" and <u>insert</u> "the recipient from knowingly using";
- (17) On page 6, line 4 and page 7, line 9, after "<u>Statutes</u>" insert ", with the exception that such prohibition shall not apply to agreements for medical services provided by Shands Jacksonville Medical Center, Inc. or to agreements for programs or services for victims of domestic violence, labor trafficking, and/or sex trafficking";
- (18) On page 7, line 7, after "from" insert "knowingly";
- (19) On page 7, line 16<sup>1</sup>/<sub>2</sub>, <u>insert</u> a new Section 6 to read as follows: "Section 6. Establishing a Prospective Effective Date of July 1, 2026, for the Amendments to Section 77.111, Ordinance Code, Contained in this Ordinance to Become Effective. The Code amendments to Section 77.111, Ordinance Code, contained in this Ordinance shall not become effective until July 1, 2026.";
- (20) Renumber the remaining Section accordingly;
- (21) On **page 1**, **line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
