AN ORDINANCE APPROPRIATING \$30,000 FROM A CONTINGENCY ACCOUNT WITHIN THE KIDS ALLIANCE ("KHA") FUND TO THE SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORGANIZATIONS ACCOUNT TO PROVIDE FUNDING TO JACKSONVILLE ARTS AND MUSIC SCHOOL INC. (c) Explanation of Appropriation:

The funding above is an appropriation of \$30,000 from a Contingency account within the Kids Hope Alliance ("KHA") Fund to the Subsidies and Contributions to Private Organizations account to provide funding to Jacksonville Arts and Music School Inc. ("JAMS") for the ArtWorks Initiative (the "Program") as described herein.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding from the City of Jacksonville to JAMS for the JAMS ArtWorks Initiative as described in Exhibit 2, attached hereto and incorporated herein by this reference. The Program is a college and career exploration program designed to prepare teens and young adults through age 24 (high school - college) for life beyond JAMS specifically targets this Program to assist graduation. first-generation college students, low-income students, students of color and other underserved students. Eligible participants are youth

who are interested in exploring a career in the creative economy, public/private business sector, or civic engagement and who desire mentorship to quide them in developing the skills necessary to achieve their goals. The Program aims to set its participants on a course towards either college or employment upon graduation from high school and/or post-secondary pathways. The City funds provided herein will aid JAMS in expanding the Program with a goal of serving a minimum of ten additional students over the next year.

Section 3. Invoking the Exemption in Section 126.108(g), Ordinance Code. The City is hereby authorized to directly procure the professional services of Jacksonville Arts and Music School Inc. for the Program as described herein. Pursuant to Section 126.108(g) from competitive solicitation), Part 1 (Exemptions (General Regulations; Ethics and Transparency in Public Contracting), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Section 4. Waiving the Requirements of Section 77.111(a), Ordinance Code. The City hereby waives the requirements of Section 77.111(a) (Provider Contracts), Chapter 77 (Kids Hope Alliance), Ordinance Code, with respect to the contract with JAMS approved and authorized by this Ordinance. Section 77.111(a) requires contracts for children's services provided by third parties to be competitively procured by KHA via an evaluated bid process. This waiver is needed in order to allow KHA to directly contract with JAMS for the ArtWorks Initiative described in Exhibit 2.

Section 5. Restriction Waiving the Age in Section 77.105(e), Ordinance Code. The City hereby waives the age provisions in Section 77.105(e) (Definitions), Chapter 77 (Kids Hope Alliance),
