14 COMMITTEES WHEN DEVELOPING THE PROPOSED

16 CONSOLIDATION CITY BOUNDARY MAP; PROVIDING AN

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Amending Section 122.604 (Preparation and**
21 **submission of the Capital Improvement Plan Budget and Capital**
22 **Improvement Plan), Part 6 (Capital Improvement Plan), Chapter 122**
23 **(Public Property), Ordinance Code.** Section 122.604 (Preparation and
24 submission of the Capital Improvement Plan Budget and Capital
25 Improvement Plan), Chapter 122 (Public Property), *Ordinance Code*,
26 is hereby amended to read as follows:

27 **CHAPTER 122. PUBLIC PROPERTY**

31 **Sec. 122.604. - Preparation and submission of the Capital**

1 **Improvement Plan Budget and Capital Improvement Plan.**

2 On or before January 15 of each year, the Department of Finance
3 and Administration, the Department of Planning and Development and
4 the Department of Public Works shall meet with all departments,
5 agencies and commissions of the City to develop a proposed Capital
6 Improvement Plan Budget for the succeeding fiscal year and a
7 proposed Capital Improvement Plan. Input from each of the six
8 Citizen Planning Advisory Committees (CPACs) shall be requested
9 and considered when developing the proposed Capital Improvement
10 Plan. The proposed Capital Improvement Plan shall include a
11 priority system developed by the Department of Finance and
12 Administration. The Mayor shall submit the proposed Capital
13 Improvement Plan Budget and the proposed Capital Improvement Plan
14 to the City Council on or before July 15 of each year.

15 **Section 2. Effective Date.** This ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor's signature.
