4 **RESOLUTION 2025-574**

5 A RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT
6 OF SYLVIA PERRY, A DUVAL COUNTY RESIDENT, AS A
7 MEMBER OF THE JACKSONVILLE JOURNEY FORWARD BOARD
8 WITH EXPERIENCE IN COMMUNITY ENGAGEMENT,
9 REPLACING DR. LATONYA M. SUMMERS, PURSUANT TO
10 SECTION 85.105, *ORDINANCE CODE*, FOR AN INITIAL
11 FOUR-YEAR TERM EXPIRING SEPTEMBER 30, 2028;
12 PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, Ordinance 2024-635-E established the Jacksonville
15 Journey Forward as a public body within the executive branch of the
16 City to assess and make recommendations regarding community-based
17 programs, services, activities, and contracts related to factors
18 contributing to crime prevention, intervention, and rehabilitation
19 as well as neighborhood safety and stability, and the prevention of
20 juvenile and adult recidivism; and

21 **WHEREAS**, the Jacksonville Journey Forward also serves as a
22 convenor to organize and engage City agencies, offices, departments,
23 independent agencies, and community leaders and stakeholders to
24 establish a community-based, Citywide plan and alignment of resources
25 to reduce factors contributing to crime and to improve public safety;
26 and

27 **WHEREAS**, Section 85.105(a), *Ordinance Code*, outlines the
28 composition of the Jacksonville Journey Forward Board ("JF Board")
29 which shall consist of eleven voting members, four of whom are
30 appointed by the Mayor and confirmed by Council, three of whom shall
31 be appointed by the Council President and confirmed by Council with

1 the following persons making one appointment for confirmation by
2 Council, to wit: the Sheriff of Duval County, the State Attorney of
3 the Fourth Judicial Circuit, the Superintendent of Duval County Public
4 Schools, and the Chief Judge for the Fourth Judicial Circuit; and

5 **WHEREAS**, to the extent feasible and preferred, but not required,
6 members appointed to serve on the JF Board shall include individuals
7 with experience in one or more of the following areas, recognizing
8 these qualifications would best serve the mission and objectives of
9 the Jacksonville Journey Forward: public health, education, workforce
10 development, contracts and compliance, afterschool/camp operations,
11 juvenile diversion programs, violence prevention or intervention, ex-
12 offender re-entry programs, law enforcement and community engagement;
13 now therefore

14 **BE IT RESOLVED** by the Council of the City of Jacksonville:

15 **Section 1. Appointment Confirmation.** The Council hereby
16 confirms the Mayor's appointment of Sylvia Perry, a Duval County
17 resident, as a member of the Jacksonville Journey Forward Board, with
18 experience in community engagement, replacing Dr. LaTonya M. Summers,
19 in accordance with Section 85.105, *Ordinance Code*, for an initial
20 four-year term expiring on September 30, 2028.

21 **Section 2. Effective Date.** This Resolution shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
