5 AN ORDINANCE APPROPRIATING \$477,324.00 FROM  
6 DUVAL COUNTY TAX COLLECTOR INVESTMENT POOL  
7 EARNINGS TO PAY FOR COMPLETION OF SURVEILLANCE  
8 SYSTEM UPGRADES AND INSTALLATION OF SECURITY  
9 BADGE ACCESS SYSTEMS AT VARIOUS TAX COLLECTOR  
10 FACILITIES, AS INITIATED BY B.T. 22-084;  
11 PROVIDING FOR CARRYOVER OF FUNDS INTO FISCAL  
12 YEAR 2022-2023; PROVIDING AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Appropriation.** For the 2021-2022 fiscal year,  
16 within the City's budget, there are hereby appropriated the indicated  
17 sum(s) from the account(s) listed in subsection (a) to the account(s)  
18 listed in subsection (b):

26 The funding above is an appropriation of Tax Collector  
27 investment pool earnings to pay for installation of  
28 surveillance system upgrades and badge access control  
29 systems at various Tax Collector facilities.

30 **Section 2. Purpose.** The purpose of the appropriation in  
31 Section 1 is to provide funding to complete surveillance system

1 upgrades for the Tax Collector offices at the Yates Building and the  
2 North Jacksonville Branch. In addition, these funds will be used to  
3 install badge access control systems to replace existing punch locks  
4 at the North Jacksonville, Neptune Beach, Mandarin, Kernan and Hogan  
5 branch offices.

6 **Section 3. Carryover.** The funds appropriated in this  
7 Ordinance shall not lapse but shall carryover to fiscal year 2022-  
8 2023.

9 **Section 4. Effective Date.** This Ordinance shall become  
10 effective upon signature by the Mayor or upon becoming effective  
11 without the Mayor's signature.
