AN ORDINANCE REGARDING INSTALLATION OF A HISTORIC MONUMENT MARKER IN HONOR OF MRS. JOHNNIE MAE CHAPPELL; APPROPRIATING \$10,000 FROM THE COUNCIL PRESIDENT'S DESIGNATED CONTINGENCY TO THE PARKS, RECREATION AND COMMUNITY SERVICES – OFFICE OF THE DIRECTOR, MISCELLANEOUS SERVICES AND CHARGES ACCOUNT TO PROVIDE FUNDS FOR THE DESIGN, FABRICATION, INSTALLATION AND MAINTENANCE OF A HISTORIC MONUMENT MARKER AS DESCRIBED HEREIN; PROVIDING FOR CARRYOVER OF FUNDS TO DECEMBER 31, 2024; PROVIDING FOR REVERTER OF FUNDS; AUTHORIZING INSTALLATION OF A HISTORIC MONUMENT MARKER AT THE INTERSECTION OF NEW KINGS ROAD AND FLICKER AVENUE TO REMEMBER AND HONOR MRS. JOHNNIE MAE CHAPPELL; FINDING A PUBLIC PURPOSE; PROVIDING FOR OVERSIGHT BY THE PARKS, RECREATION AND COMMUNITY SERVICES DEPARTMENT AND THE DEPARTMENT OF PUBLIC WORKS; DIRECTING THE LEGISLATIVE SERVICES DIVISION TO FORWARD A COPY OF THIS ORDINANCE, ONCE ENACTED, TO THE DIRECTORS OF THE PARKS, RECREATION AND COMMUNITY SERVICES DEPARTMENT AND THE DEPARTMENT OF PUBLIC WORKS; PROVIDING AN EFFECTIVE DATE.
