7 **ORDINANCE 2025-110-E**

8 AN ORDINANCE APPROVING AND AUTHORIZING THE
9 MAYOR, OR HER DESIGNEE, AND THE CORPORATION
10 SECRETARY TO EXECUTE AND DELIVER TWO FIRST
11 AMENDMENTS TO FISCAL YEAR 2023-2024 CURE
12 VIOLENCE SERVICES CONTRACTS BETWEEN THE CITY OF
13 JACKSONVILLE ("CITY") AND THE POTTER'S HOUSE
14 COMMUNITY DEVELOPMENT EMPOWERING CENTER, INC. TO
15 EXTEND THE TERM AND AMEND THE PROGRAM BUDGET
16 DETAIL; PROVIDING FOR CITY OVERSIGHT BY THE
17 GRANTS AND CONTRACT COMPLIANCE DIVISION;
18 PROVIDING AN EFFECTIVE DATE.

20 **WHEREAS,** the City of Jacksonville (the "City") and The Potter's
21 House Community Development Empowering Center, Inc. ("Recipient"),
22 previously entered into that certain Fiscal Year 2023-2024 Cure
23 Violence Services Contract (Northside) dated October 1, 2023
24 ("Northside") and that certain Fiscal Year 2023-2024 Cure Violence
25 Services Contract (Westside) dated October 1, 2023 ("Westside")
26 (collectively, the "Contracts"), as authorized by Ordinance
27 2023-504-E, to provide funding from the City to Recipient in the
28 amount of \$303,333.00 and \$309,166.00, respectively, (the "Maximum
29 Indebtedness") to be used to implement the Cure Violence Public Health
30 Violence Reduction Model to interrupt violent conflicts and eliminate
31 violence; and

1 **WHEREAS,** Recipient has requested to amend the Contracts to
2 adjust the program budget details in order to reallocate funding
3 between certain line items of the budget without increasing the
4 Maximum Indebtedness and extend the term of the Contracts to allow
5 the City to close out the contract and keep the Recipient off of the
6 City's Non-Compliance List in accordance with the revised program
7 budget detail; and

8 **WHEREAS,** the term of the Contracts expired on January 31, 2024,
9 and Recipient has requested the City to enter into a First Amendment
10 to Fiscal Year 2023-2024 Cure Violence Services Contract (Northside)
11 in substantially the form attached hereto as **Revised Exhibit 1,**
12 labeled as "Revised Exhibit 1, Rev 1st Amd (Northside), March 3, 2025
13 - NCSPHS" and a First Amendment to Fiscal Year 2023-2024 Cure Violence
14 Service Contract (Westside) in substantially the same form attached
15 hereto as **Revised Exhibit 2,** labeled as "Revised Exhibit 2, Rev 1st
16 Amd (Westside), March 3, 2025 - NCSPHS" both of which being
17 incorporated herein by this reference (the "Amendments") having an
18 effective date of January 31, 2024 to revive the Contracts and
19 maintain contractual continuity; now therefore

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Approval and Authorization to Execute Amendments**
22 **to Contracts.** There is hereby approved, and the Mayor, or her
23 designee, and the Corporation Secretary are hereby authorized to
24 execute and deliver the Amendments. The Amendments amend certain line
25 items of the Budget/Fee Schedules and Complete Program Budget Details
26 to reallocate funding to allow for unforeseen expenses and to correct
27 a discrepancy, without increasing the Maximum Indebtedness, in order
28 to stay off of the City's Non-Compliance List, and extend the term
29 of the Contracts to allow the City to close out the Contracts, with
30 all other terms and conditions of the Contracts remaining unchanged.

31 **Section 2. Oversight Department.** The Grants and Contract

1 Compliance Division of the Finance Department shall continue to have
2 oversight of the Contracts described herein.

3 **Section 3. Effective Date.** This Ordinance shall become
4 effective upon signature by the Mayor or upon becoming effective
5 without the Mayor's signature.
