5 AN ORDINANCE CONFIRMING THE MAYOR'S  
6 APPOINTMENT OF CHRISTOPHER R. BUTLER, A ST.  
7 JOHNS COUNTY RESIDENT WITH SUBSTANTIAL  
8 BUSINESS INTEREST IN DUVAL COUNTY, TO THE  
9 BETTER JACKSONVILLE PLAN FINANCIAL  
10 ADMINISTRATION COMMITTEE, AS A PRIVATE  
11 CITIZEN, REPLACING PAUL SLEIMAN, PURSUANT TO  
12 SECTION 761.107, *ORDINANCE CODE*, FOR A FIRST  
13 FULL TERM TO EXPIRE MARCH 31, 2026; PROVIDING  
14 FOR A NON-RESIDENT OF DUVAL COUNTY WITH  
15 SUBSTANTIAL ECONOMIC BUSINESS INTEREST TO BE  
16 SEATED ON THE BETTER JACKSONVILLE PLAN  
17 FINANCIAL ADMINISTRATION COMMITTEE; PROVIDING  
18 AN EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appointment.** The Council hereby confirms the  
22 Mayor's appointment of Christopher R. Butler, a St. Johns County  
23 resident with substantial business interest in Duval County, to the  
24 Better Jacksonville Plan Financial Administration Committee, as a  
25 private citizen, replacing Paul Sleiman, pursuant to Section  
26 761.107, *Ordinance Code*, for a first full term to expire March 31,  
27 2026.

28 **Section 2. A Non-Resident of Duval County with**  
29 **substantial economic business interests in Duval County.** Section  
30 50.102 (Members of boards and commissions), *Ordinance Code*,  
31 requires Board and Commission members be either a Duval County

1 resident or individuals with substantial economic business or  
2 philanthropic interests in Duval County. Mr. Butler has substantial  
3 business interests in Duval County. Mr. Butler serves as the  
4 Managing Partner of DF Capital Management, an affiliate of Dream  
5 Finders Homes, located at 14701 Philips Hwy, Jacksonville, FL  
6 32256.

7 **Section 3. Effective Date.** This ordinance shall become  
8 effective upon signature by the Mayor or upon becoming effective  
9 without the Mayor's signature.
