8 EXECUTE AND DELIVER ON BEHALF OF THE CITY, THE
9 AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND
10 JACKSONVILLE UNIVERSITY FOR THE JACKSONVILLE
11 UNIVERSITY WOMEN'S HEALTH INNOVATION HUB PROJECT
12 (THE "PROJECT"), AS ORIGINALLY AUTHORIZED BY
13 ORDINANCE 2024-460-E, TO INCORPORATE A REVISED
14 TERM SHEET AND BUDGET FOR THE PROJECT AS
15 DESCRIBED HEREIN; PROVIDING FOR CONTINUED
16 OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE
17 DIVISION OF THE FINANCE DEPARTMENT; PROVIDING
18 FOR CARRYOVER OF FUNDS TO FISCAL YEAR 2025-2026;
19 PROVIDING AN EFFECTIVE DATE.

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Approval and Authorization to Execute.** There is
23 hereby approved, and the Mayor, or her designee, and the Corporation
24 Secretary are hereby authorized to execute and deliver on behalf of
25 the City the funding agreement with Jacksonville University as
26 originally authorized by Ordinance 2024-460-E, subject to the revised
27 Term Sheet and Budget attached hereto as **Exhibit 1**, and incorporated
28 herein by this reference, and all other contracts and documents,
29 including extensions, renewals and amendments to the agreement, and
30 to otherwise take all action necessary to effectuate the intent of
31 this Ordinance, subject to appropriate legal review and approval by

1 the General Counsel, or his or her designee, and the City's Risk
2 Management Division for appropriate insurance and indemnification
3 requirements in accordance with Section 128.601, *Ordinance Code*.

4 **Section 2. Oversight.** The Grants and Contract Compliance
5 Division of the Finance Department shall continue to oversee the
6 grant and agreements described herein.

7 **Section 3. Carryover.** The funds appropriated by Ordinance
8 2024-460-E shall not lapse but shall carryover to fiscal year 2025-
9 2026.

10 **Section 4. Effective Date.** This Ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
