A RESOLUTION HONORING AND CONGRATULATES RUTH LOUISE GRAHAM RAY ON THE OCCASION OF HER 107TH BIRTHDAY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Jacksonville native Ruth Louise Graham Ray was born on October 31, 1912, the daughter of Darius and Ruth Dixon Graham, and graduated from Stanton High School in 1930; and

WHEREAS, Ms. Ray was educated at Bethune-Cookman College (Associate of Science degree, Tuskegee University (Bachelor's degree) and Hampton University (Master's degree) and did additional study at Florida A&M University, the University of Florida, the University of Michigan and New York University; and

WHEREAS, Ruth Ray had an abiding love of learning and teaching from a very young age, began her teaching career in the Duval County School District in 1933, and retired from Florida State College at Jacksonville (formerly FCCJ) in 1983 after providing 50 years of excellence in teaching and counseling, following in the footsteps of her mother who also taught for 50 years; and

WHEREAS, in addition to teaching, one of Ms. Ray's other abiding passions was the Girl Scouts, where she served for over 40 years as a troop leader and as a certified national trainer for troop leaders. She was one of the first African-American troop leaders in Jacksonville to attend the Edith Macy National Training Schools for the Girls Scouts of America in 1953; and

WHEREAS, Ruth Ray has a wide range of other interests,

including national and international travel, sports, music and prose and poetry writing; and

WHEREAS, at the age of 107, Ms. Ray, who for over 40 years served as Secretary of the Trustee Ministry at Bethel Baptist Church where she is now the oldest member, has positively impacted the lives of thousands of people through her work, her writing, her music and her friendship; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

The City of Jacksonville hereby honors and congratulates Ruth Louise Graham Ray on the occasion of her 107<sup>th</sup> birthday and thanks her for her countless contributions over her long life to her students, her church and her community.
