16 Closure and Abandonment. Section 1. An unopened and 17 unimproved portion of Branan Field Road as recorded in Plat Book 5, 18 Page 93, Jacksonville Heights Improvement Company, of the current 19 public records of Duval County, Florida, located in Council District 12, a depiction and description of which is attached hereto as Exhibit 20 21 1 and incorporated herein by this reference, is hereby closed and 22 abandoned and/or disclaimed at the request of Kay C.
