11 YATES BUILDING TO SERVE AS THE DUVAL COUNTY TAX
12 COLLECTOR'S RECEPTION AND WAITING AREA, DROP-
13 OFF LOCKER FOR CAR DEALERS AND TITLE SERVICE
14 OFFICE, AS INITIATED BY B.T. 24-067; PURPOSE OF
15 APPROPRIATION; PROVIDING FOR CARRYOVER OF FUNDS
16 INTO FISCAL YEAR 2024-2025; PROVIDING AN

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
21 within the City's budget, there are hereby appropriated the indicated
22 sum(s) from the account(s) listed in subsection (a) to the account(s)
23 listed in subsection (b):

31 The funding above is an appropriation of funds from Tax

1 Collector Interest Earnings 361105 Account to the TCSG Tax
2 Collector General Operations - Financial and
3 Administration Account. These funds are not part of the
4 City's pooled earnings. No City match is required.

5 **Section 2. Purpose.** The purpose of the appropriation in
6 Section 1 is to provide funding for the remodeling, build-out and
7 furnishing of a section of the first floor of the Yates Building,
8 which is the Main Branch of the Duval County Tax Collector. This area
9 on the first floor will be remodeled into a reception and waiting
10 area, will provide a secure drop-off locker solution for car dealers
11 and will create a Title Services Office.

12 **Section 3. Carryover.** The funds appropriated in this
13 Ordinance shall not lapse but shall carryover to fiscal year 2024-
14 2025.

15 **Section 4. Effective Date.** This Ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor's signature.
