5 AN ORDINANCE APPROPRIATING \$100,000.00 FROM THE
6 CITY HALL ST. JAMES - JUDGEMENTS RECOVERED
7 ACCOUNT WITHIN THE PUBLIC BUILDING ALLOCATIONS
8 FUND, TO PAY THE COSTS FOR REPAIRS TO THE ST.
9 JAMES BUILDING (CITY HALL) ELEVATORS; PROVIDING
10 FOR PROJECT OVERSIGHT BY THE DEPARTMENT OF
11 PUBLIC WORKS, PUBLIC BUILDINGS DIVISION;
12 PROVIDING AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Appropriation.** For the 2025-2026 fiscal year,
16 within the City's budget, there is hereby appropriated the indicated
17 sum(s) from the account(s) listed in subsection (a) to the account(s)
18 listed in subsection (b):

20 by this reference)

25 (c) Explanation of Appropriation:

26 The funding above is an appropriation of \$100,000.00 from
27 the City Hall St. James - Judgements Recovered account to
28 the City Hall St. James - Contractual Services account
29 within the Public Building Allocations Fund, to pay for
30 costs associated with elevator repairs for the St. James
31 Building (City Hall). This appropriation of funds is

1 subject to the City's receipt of funds from a settlement
2 of the lawsuit filed by the City in the Fourth Judicial
3 Circuit styled City of Jacksonville v. Otis Elevator
4 Company, Duval County Circuit Court Case No. 16-2024-CA-
5 000270 (the "Lawsuit"), which related to breach of contract
6 and damages arising out of elevator service and elevator
7 maintenance at several buildings owned by the City.

8 **Section 2. Purpose.** The purpose of the appropriation in
9 Section 1 is to provide funding for repairs to the City Hall elevator
10 systems needed to address ongoing elevator maintenance and service
11 issues. The funds appropriated are to be paid to the City pursuant
12 to a Settlement Agreement and Release to be entered into by Otis
13 Elevator Company and the City, subject to Council approval, resolving
14 the Lawsuit.

15 **Section 3. Oversight Department.** The Department of
16 Public Works, Public Buildings Division, shall oversee the project
17 described herein.

18 **Section 4. Effective Date.** This Ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
