RESOLUTION 2025-358

A RESOLUTION CONFIRMING THE APPOINTMENT OF DR. LANTIE ELISABETH JORANDBY, AS A MEMBER OF THE OPIOID AND SUBSTANCE USE DISORDER GRANTS COMMITTEE, AS A HEALTHCARE PROFESSIONAL REPRESENTATIVE, PURSUANT TO SECTION 84.202 (COMPOSITION; CITY COUNCIL LIAISON; TERMS; REMOVAL), PART 2 (OPIOID AND SUBSTANCE USE DISORDER GRANTS COMMITTEE), CHAPTER 84 (OPIOID SETTLEMENT PROCEEDS GRANTS), *ORDINANCE CODE*, FOR A SECOND FULL TERM ENDING ON JUNE 30, 2028; ESTABLISHING SUBSTANTIAL BUSINESS INTEREST IN DUVAL COUNTY, PURSUANT TO SECTION 50.102(B) (RESIDENCY REQUIREMENT) (MEMBERS OF BOARDS AND COMMISSIONS), PART 1 (ORGANIZATION), CHAPTER 50 (ORGANIZATION OF BOARDS AND COMMISSIONS), *ORDINANCE CODE*; PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. Appointment. The Council hereby confirms the Mayor's appointment of Dr. Lantie Elisabeth Jorandby to the Opioid and Substance Use Disorder Grants Committee, as a Healthcare Professional representative, in accordance with Section 84.202 (Composition; City Council Liaison; Terms; Removal), Part 2 (Opioid and Substance Use Disorder Grants Committee), Chapter 84 (Opioid Settlement Proceeds Grants), *Ordinance Code*, for a second full term expiring on June 30, 2028.

Section 2. A Non-Resident of Duval County with substantial

1 **economic business interests in Duval County.** Section 50.102 (Members
2 of Boards and Commissions), Part 1 (Organization), Chapter 50
3 (Organization of Boards and Commissions), *Ordinance Code*, requires
4 Board and Commission members be either a Duval Country resident or
5 individuals with substantial economic business interests in Duval
6 County. Dr. Jorandby has substantial business interests in Duval
7 County. Since 2019, Dr. Jorandby has been serving as the Chief Medical
8 Officer for Lakeview Health, a dual diagnosis treatment facility
9 located in Jacksonville, Florida.

10 **Section 3. Effective Date.** This Ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
