11 Section 4. Waiving the Conflicting Provisions of Section 12 10.105, Ordinance Code. The provisions of Section 10.105 (Postage and 13 communication expenses of council members), Chapter 10 (Organization 14 of the Council), Ordinance Code, are hereby waived to allow for a 15 postage allowance for Council Members as provided herein.

Section 5. Funding Allocation for Council Member Postage
Expenses. Each District Council Member shall be allotted \$1,000 per
District Council Member for postage expenses. The remaining \$36,000
budgeted for postage in Fiscal Year 2025-2026 shall be distributed
at the discretion of the Council President to all Council Members.

21 Section 6. Effective Date. This Ordinance shall become 22 effective upon signature by the Mayor or upon becoming effective 23 without the Mayor's signature.
