4 **ORDINANCE 2022-569**

5 AN ORDINANCE APPROPRIATING GRANT FUNDS IN THE  
6 AMOUNT OF \$500,000.00 FROM THE STATE OF FLORIDA  
7 DEPARTMENT OF ECONOMIC OPPORTUNITY FLORIDA  
8 DEFENSE INFRASTRUCTURE GRANT PROGRAM THROUGH THE  
9 FLORIDA DEFENSE SUPPORT TASK FORCE ("FDSTF") AND  
10 ADMINISTERED BY ENTERPRISE FLORIDA, INC., TO  
11 SUPPORT THE CITY'S ENCROACHMENT  
12 PROTECTION/COMPATIBLE LAND USE PROGRAM FOR THE  
13 PURCHASE OF RESTRICTIVE USE EASEMENTS ON  
14 PROPERTIES WITHIN THE MILITARY INFLUENCE ZONE  
15 SURROUNDING DUVAL COUNTY NAVAL BASES AND  
16 AIRFIELDS, AS INITIATED BY B.T. 22-096;  
17 APPROVING, AND AUTHORIZING THE MAYOR, OR HIS  
18 DESIGNEE, AND THE CORPORATION SECRETARY TO  
19 EXECUTE AND DELIVER THE GRANT AGREEMENT BETWEEN  
20 THE CITY OF JACKSONVILLE AND ENTERPRISE FLORIDA,  
21 INC. FOR THE FLORIDA DEFENSE SUPPORT TASK FORCE;  
22 PROVIDING FOR OVERSIGHT BY THE MILITARY AFFAIRS  
23 AND VETERANS DEPARTMENT; PROVIDING AN EFFECTIVE  
24 DATE.

26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Appropriation.** For the 2021-2022 fiscal year,  
28 within the City's budget, there is hereby appropriated the indicated  
29 sum(s) from the account(s) listed in subsection (a) to the account(s)  
30 listed in subsection (b):

6 (c) Explanation of Appropriation

7 The funding above is a grant from the State of Florida  
8 Department of Economic Opportunity through the Florida  
9 Defense Support Task Force ("FDSTF") and administered by  
10 Enterprise Florida, Inc. These funds will be used to  
11 support the City's Encroachment Protection/Compatible  
12 Land Use Program for the procurement of restrictive use  
13 easements on properties within the Military Influence Zone  
14 surrounding Naval bases and airfields in Duval County. The  
15 grant period commences on July 1, 2022 and continues  
16 through June 30, 2023. No local match is required.

17 **Section 2. Purpose.** The purpose of the appropriation in

18 Section 1 is to allocate grant funds from the State of Florida  
19 Department of Economic Opportunity through FDSTF for the City's  
20 Encroachment Protection/Compatible Land Use Program (the "Program").  
21 The Program was established in partnership with the United States  
22 Department of the Navy to protect naval bases and airfields in Duval  
23 County from encroachment by incompatible land uses and development  
24 within the Military Influence Zones through the procurement of  
25 restrictive use easements. These grant funds will be utilized along  
26 with funding from the Department of Defense in furtherance of the  
27 Program's objective by purchasing additional restrictive use  
28 easements on properties surrounding NS Mayort, NAS Jacksonville and  
29 OLF Whitehouse. These easements are acquired from willing sellers  
30 to secure Duval County's Navy bases and airfields from encroachment  
31 and to minimize community concerns regarding aircraft traffic and

1 noise.

2           **Section 3.           Approval and Authorization.**   There is hereby  
3 approved, and the Mayor, or his designee, and the Corporation  
4 Secretary are hereby authorized to execute and deliver, for and on  
5 behalf of the City, the Grant Agreement between the City of  
6 Jacksonville and Enterprise Florida, Inc. for the Florida Defense  
7 Support Task Force, a copy of which has been placed **On File** with the  
8 Office of Legislative Services.

9           **Section 4.           Oversight.**   The Military Affairs and Veterans  
10 Department shall oversee administration of the grant described  
11 herein.

12           **Section 5.           Effective Date.**   This Ordinance shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
