4 **ORDINANCE 2021-110**

5 AN ORDINANCE AUTHORIZING THE GRANTING OF A
6 NON-RESIDENTIAL SOLID WASTE COLLECTION AND
7 TRANSPORTATION FRANCHISE TO GFL SOLID WASTE
8 SOUTHEAST, LLC PURSUANT TO CHAPTER 380 (SOLID
9 WASTE MANAGEMENT), PART 6 (NONRESIDENTIAL
10 SOLID WASTE COLLECTION AND TRANSPORTATION
11 FRANCHISES), *ORDINANCE CODE*; PROVIDING FOR
12 OVERSIGHT BY THE DEPARTMENT OF PUBLIC WORKS,
13 SOLID WASTE DIVISION; PROVIDING AN EFFECTIVE
14 DATE.

16 **WHEREAS**, GFL Solid Waste Southeast, LLC has submitted an
17 application for a non-residential solid waste collection and
18 transportation franchise pursuant to the provisions of Chapter 380,
19 Part 6, *Ordinance Code*; and

20 **WHEREAS**, the application was reviewed by the Solid Waste
21 Division of the Department of Public Works; and

22 **WHEREAS**, the Department of Public Works recommends granting a
23 franchise for non-residential solid waste collection and
24 transportation to GFL Solid Waste Southeast, LLC; and

25 **WHEREAS**, granting a non-residential solid waste collection and
26 transportation franchise to GFL Solid Waste Southeast, LLC will
27 further the purpose for which the franchise program was adopted,
28 including, but not limited to, safeguarding public health, safety
29 and welfare in the collection and transportation of solid waste
30 through Jacksonville; now therefore

31 **BE IT ORDAINED** by the Council of the City of Jacksonville:

1 **Section 1. Franchise Agreement authorized.** In accordance
2 with the provisions of Chapter 380 (Solid Waste Management), Part 6
3 (Nonresidential Solid Waste Collection and Transportation
4 Franchises), *Ordinance Code*, the Director of the Public Works
5 Department is hereby authorized to issue a franchise agreement to
6 GFL Solid Waste Southeast, LLC for collection and transportation of
7 non-residential solid waste in the City of Jacksonville. GFL Solid
8 Waste Southeast, LLC has paid the application fee of \$1,500.00. A
9 copy of the Non-Residential Solid Waste Collection and
10 Transportation Franchise Agreement is attached hereto as **Exhibit 1**
11 and incorporated herein by this reference. A copy of the letter
12 from the Department of Public Works forwarding GFL Solid Waste
13 Southeast, LLC's application to the Council for action is attached
14 hereto as **Exhibit 2** and incorporated herein by this reference.

15 **Section 2. Oversight.** The Solid Waste Division of the
16 Department of Public Works shall oversee the franchise described
17 herein.

18 **Section 3. Effective Date.** This ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
