The City of Jacksonville continues to benefit from the vital contributions of the Retired Employees Association of the Consolidated City of Jacksonville with retired employees serving on Pension Trustee Boards, Pension Advisory Committees and numerous Boards and Committees of the Consolidated Government, now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:
