## PROGRAM OVERVIEW:

Ronald McDonald House Charities of Jacksonville, Inc. ("RMHCJ") provides essential services that remove barriers, strengthen families and promote healing when children need healthcare. We help alleviate the mental stress of meal planning and the financial strain of providing dinner for families staying at the House by providing a well-balanced meal for our families 365 nights a year through our Warm Meals, Warm Hearts Meal Program.

RMHCJ has a longstanding partnership with Wolfson Children's Hospital as we work together to serve children with critical medical needs. Wolfson Children's has identified a recurring theme that many families staying at Wolfson, who are unable to leave the hospital, are struggling with having their basic food needs met. When parents have a critically ill child, and do not want to leave the hospital, their health and basic needs become secondary.

RMHCJ, along with Wolfson Children's, will address this immediate unmet need by providing individuals and families with well-balanced and nutritious meals through our Warm Meals, Warm Hearts Meal Program.

## PROGRAM SCOPE OF WORK AND DELIVERABLES:

- Social workers at Wolfson Children's will identify a targeted group of individuals and families, at the greatest risk for food insecurity, to refer to our meal Program.
- Meals will be prepared and cooked at the House alongside the meals prepared for families staying at RMHCJ.
- Meals will be packaged in to-go containers and delivered in warmers for the targeted families at Wolfson Children's.

## PROGRAM COSTS/PAYMENT TERMS:

City funds shall be expensed in accordance with the approved budget. Funds will be disbursed on a reimbursement basis upon the City's receipt and approval of required documentation including but not limited to paid invoices, cleared checks and bank statements.

# **PROGRAM IMPACT & REPORTING:**

RMHCJ provides nightly dinners 365 nights a year through our industrial kitchen and dining room. In addition, the communal kitchen is stocked with grab and go breakfast, lunch and snack items. Families also have complete access to the communal food pantry at the House. For the expansion, RMHCJ will offer nightly dinners to targeted families at Wolfson Children's. Meals will be prepared and cooked at the House alongside the meals prepared daily for families staying on-site at RMHCJ. The meals will be packaged in to-go containers and delivered in warmers for the targeted families at Wolfson Children's.

The data analysis for Warm Meals, Warm Hearts is based on two different sets of data. The first is our Family Registry database. Through this database, we track the number of families and individuals we serve daily. The second is our nightly dinner count. This is tracked by our Food Services Manager and is based on the number of meals served. With the expansion, we will track the number of meals delivered to Wolfson Children's. In the initial phase of the meal Program expansion, RMHCJ hopes to provide 30 meals per night to a targeted group of high-risk families at Wolfson Children's. Wolfson Children's will track and provide data on these families so we can best ensure we are serving families with highest risk and need.

With these two sets of data we calculate the monthly meals served, families served, and individuals served. This monthly number is used to track our progress of hitting our metrics of meals, families and individuals served by the end of the year.

Upon completion of the grant period, RMHCJ will provide a report to the City detailing the data collocated and meals provided.

# ADDITIONAL GRANT REQUIREMENTS AND CONDITIONS:

Recipient's expenditure of City funds for the Program and the provision of services shall be subject to Chapter 118, Parts 1 – 5 of the *Jacksonville Ordinance Code*, and the terms and conditions of any contract entered into between the City and Recipient. Recipient shall use the City funds for the Program in accordance with the City Council approved Term Sheet and Program budget. The City's Grant Administrator may amend this Term Sheet or the approved Program budget consistent with the Program's needs, provided that any substantial change to this Term Sheet or a budget change not within 10% of the attached Program budget line-items will require City Council approval.
