Pursuant to the authorization by the governing body of the Jacksonville Housing Finance Authority (the "JHFA"), I conducted a public hearing on June 15, 2021 at 10:00 a.m. via toll-free telephonic conference line in lieu of physical presence at the public hearing, with respect to the contemplated issuance by the JHFA of its Multifamily Housing Revenue Bonds (Pine Grove Apartments), Series 2021 in an amount not to exceed \$28,590,000 (the "Bonds").
