Duval County Supervisor of Elections Proposed Precinct Boundaries City Council District 4



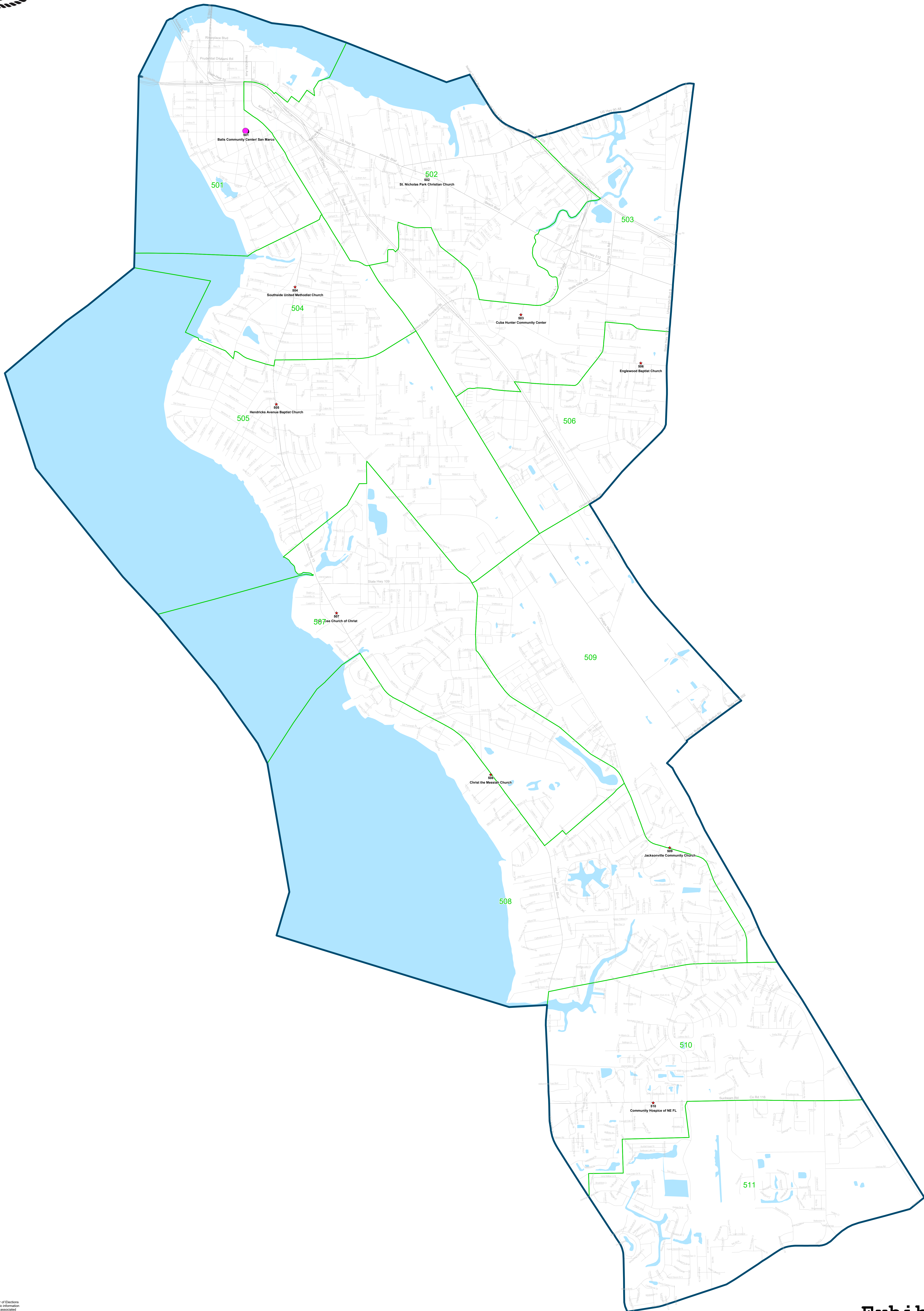
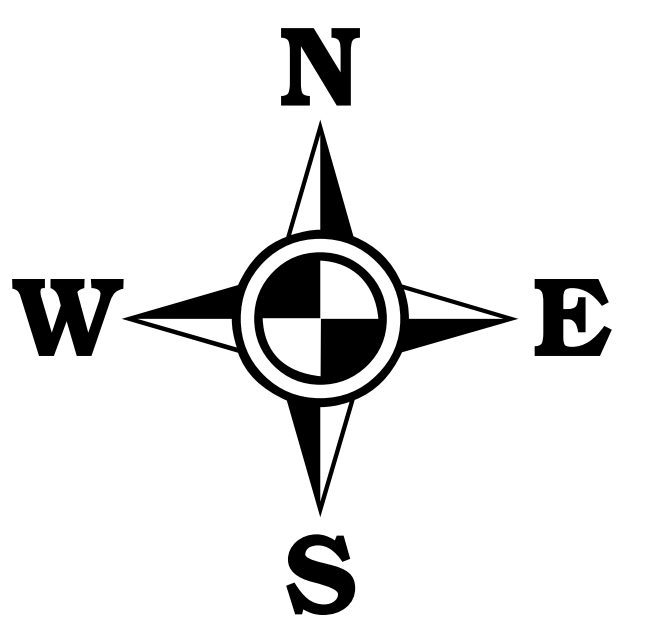
